The Missouri Highways and Transportation Commission is requesting the services of a consulting engineering firm to perform the described professional services for the project included on the attached list.

We will utilize the consultant information already on file so we will not need a lengthy submittal of other general company information.

DBE firms must be certified by the Missouri Department of Transporation in order to be counted as participation towards an established DBE Goal. We encourage DBE firms to submit letters of interest as prime consultants for any projects they feel can be managed by their firm.

We request all letters be received by 4:00 pm, September 12, 2005 at the appropriate office.

As of September 1, 2005, requests for professional services will no longer be sent through the U.S. Mail. They will be posted on MoDOT's web site and an e-mail will be sent to you when a new solicitation has been posted. Follow the instructions below to the web page where the solicitations are posted:
