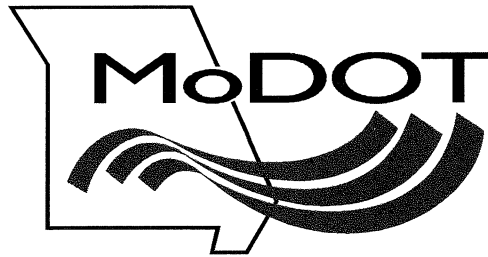

DBE firms must be certified by the Missouri Department of Transportation in order to be counted as participation towards an established DBE Goal. We encourage DBE firms to submit letters of interest as prime consultants for any projects they feel can be managed by their firm.

We request all letters be received by 4:00 pm, April 14, 2006 at the appropriate office.

Proposed Improvement:	To provide fiber optic cable and wireless interconnect system within existing traffic signals and connect these system to existing MoDOT backbone fiber cable system and bring these data to MoDOT D6 TMC (Transportation Management Center).
Length:	Approx. 16 miles
