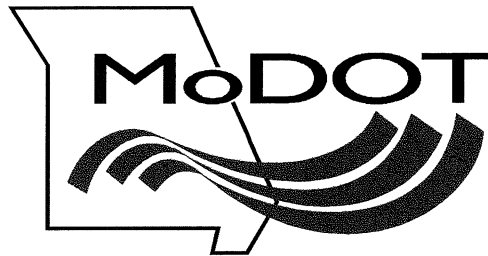

We will utilize the consultant information already on file so we will not need a lengthy submittal of other general company information.

DBE firms must be certified by the Missouri Department of Transportation in order to be counted as participation towards an established DBE Goal. We encourage DBE firms to submit letters of interest as prime consultants for any projects they feel can be managed by their firm.

We request all letters be received by 4:00 pm, March 31, 2006 at the appropriate office.

<b>Location:</b>	Over Little Indian Creek, 3.0 miles west of Rte. 13 and over Big Indian Creek, 6.0 miles west of Rte. 13.
<b>Proposed Improvement:</b>	Grading, drainage, and bridge rehabilitation on Bridge No. A05871 and Bridge No. A05861.
<b>Length:</b>	0.086 miles and 0.111 miles, respectively.
<b>Approximate Construction Cost:</b>	\$820,000 and \$751,000, respectively.
<b>Consultant Services Required:</b>	Construction inspection.
<b>Other Comments:</b>	<p>The consultant will be responsible for providing construction inspection staff for quality assurance and full contract administration, including change orders and SiteManager data entry.</p> <p>The consultant will inspect contractor activities in accordance with the 2004 Missouri Standard Specifications, Missouri General Construction Manual, and all other contract documents, including the construction plans, specifications, and special provisions.</p> <p>Work will be under the supervision of the Resident Engineer in charge. The project letting was February 24, 2006. The contractor's notice to proceed of April 10, 2006, is dependent upon the Commission awarding the project. The project completion date is November 1, 2006.</p>
