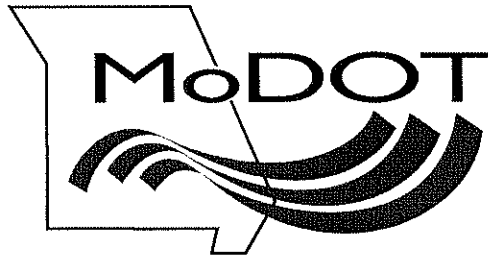

The Missouri Highways and Transportation Commission is requesting the services of a consulting engineering firm to perform the described professional services for the project included on the attached list.

We will utilize the consultant information already on file so we will not need a lengthy submittal of other general company information.

DBE firms must be certified by the Missouri Department of Transportation in order to be counted as participation towards an established DBE Goal. We encourage DBE firms to submit letters of interest as prime consultants for any projects they feel can be managed by their firm.

We request all letters be received by 3:00 pm, February 13, 2009 at the appropriate office.

<b>St. Charles County Route 364</b>	
<b>Job No:</b>	J6U1028B
<b>Location:</b>	0.3 miles west of Central School Road to Mid Rivers Mall Drive.
<b>Proposed Improvement</b>	Construct Route 364 (Page Avenue) by converting Route 94 into a freeway with one-way outer roads, bridges and slip ramps.
<b>Length</b>	Total project length is 1.6 miles
<b>Approximate Construction Costs</b>	\$40,000,000 (including Non-Contractual and MoDOT furnished items)
<b>DBE Goal (if anticipated)</b>	15%
