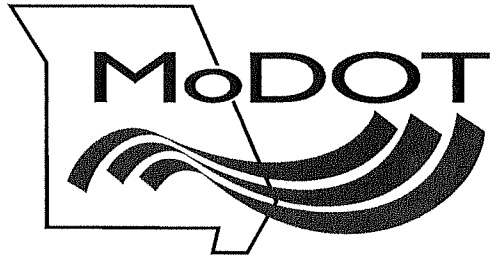

DBE firms must be certified by the Missouri Department of Transportation in order to be counted as participation towards an established DBE Goal. We encourage DBE firms to submit letters of interest as prime consultants for any projects they feel can be managed by their firm.

We request all letters be received by 3:00 pm, March 26, 2010 at the appropriate office.

Management of freeways, arterials, incidents, and work zones – the team shall have the knowledge and understanding to proactively and aggressively manage the traffic congestion influenced by these conditions, working with advanced transportation management systems. 4.
