The City of Perryville, Missouri, is hereby soliciting Statements of Qualifications (SOQ) and experience from airport consultants for projects at Perryville Municipal Airport anticipated to be completed over the next five (5) years. These projects may include:

- 1. Installation of AWOS (Estimated cost \$300,000)
- 2. Airport Fuel Facility (Estimated cost \$500,000)
- 3. Concrete pads with aircraft tiedowns (Estimated cost \$50,000)
- 4. Ramp rehabilitation (Estimated cost \$2,880,000)
- 5. Airport security and fencing (Estimated cost \$200,000)
- 6. Airport terminal development (Estimated cost \$350,000)
- 7. Runway obstruction removal (Estimated cost \$300,000)
- 8. Development of Instrument Landing System (ILS) (Estimated cost \$3,000,000)
- 9. Perform Aeronautical Surveys for Instrument Approach Procedure Development and GIS Requirements.
- 10. Development of an Airport Layout Plan (ALP) and Narrative or Master Plan
- 11. Preparation of a Certificate of Title, including an Exhibit "A" Property Map
- 12. Assistance with required environmental actions and documentation
- 13. Assistance with land acquisition for airport development, and for compliance with FAA standards and regulations
- 14. Airport lighting/electrical or navigational aid improvements
- 15. Airport pavement rehabilitation, maintenance, earthwork, and improvements, e.g. runway extension, crack-fill, seal-coat, overlay, grading, marking, etc. (Estimated cost \$600,000)

The required services include, but are not limited to, airport planning, design, construction, A/E services for all phases, and necessary incidental services for projects expected to be funded under the FAA Airport Improvement Program within five years. - An implemented Affirmative Action Program
- Capacity to perform work in the allotted time
- Capability to complete projects within budgets
- Capability to furnish qualified inspectors for construction inspection
- Familiarity with, and proximity to the project

Fees will be negotiated for projects as grants are obtained. **Consultants shall not include fee or cost information when responding to this solicitation**. Prospective consultants are advised that applied overhead rates must be in accordance with the cost principles established within Federal Regulation 48 CFR Part 31, Contract Cost Principles and Procedures.
