Sealed proposals will be received at the Office of The Sainte Genevieve County Commission, 55 South Third Street, Sainte Genevieve, Missouri 63670, until **10:00 AM** on April 16th, 2020.

The project consists of furnishing all labor, tools, equipment and materials for grading / regrading of the roadway, installation of culverts, and placing of rip-rap together with other associated items as noted within the Plans for this Project.

Proposals will be publicly opened and read aloud at **10:00 AM** on April 16th, 2020 within the office of The Sainte Genevieve County Commission, 55 South Third Street, Sainte Genevieve, Missouri 63670. Bidders are advised that anyone attending the bid opening will be screened prior to admittance, and anyone deemed a health risk will not be admitted. A teleconference number will be made available prior to the pre-bid meeting and bid opening for contractors wishing to attend remotely. All bidders are required to purchase plans and specifications in order to submit a bid for this project.

A pre-bid conference will be held at **10:00 AM** on April 6<sup>th</sup>, 2020, at the Office of The SAINTE GENEVIEVE COUNTY COMMISSION, 55 South Third Street, Sainte Genevieve, Missouri 63670. **This meeting shall be NON-MANDATORY.**

The Contract provides for the furnishing of all labor, equipment, and materials necessary for the improvement and construction required per the improvement plans, specifications and construction documents.

A certified or cashier's check, or bid bond executed by the bidder and by an approved Surety Company, in the amount of five (5) percent of the bid shall be submitted with each Proposal.

Plans, specifications, proposal form, and contract for said improvement may be reviewed and/or obtained in the office of the Engineer, Koehler Engineering and Land Surveying, 194 Coker Lane, Cape Girardeau, Missouri 63701. A **non-refundable** fee of \$ **50.00** per set is required.

All wages paid for work under this Contract shall comply with requirements of the current prevailing wage law of the State of Missouri, Sec. 290.210 through 290.340, R.S. Mo. 1978, as amended. Bidders must agree to comply with all statutory regulations referred to in the specifications.

Weekly certified payrolls will be required from the General Contractor and all Subcontractors.

This project has a Disadvantaged Business Entity (DBE) Participation rate of 9.0%, as outlined in the project bid documents.

This project will require all workers on the project site to have current OSHA 10 certifications at a minimum, as outlined in the project bid documents.
