# ADDENDUM No. 3

Dear Vendor,

The original IFB remains in effect except as revised by the following changes, which shall take precedence over anything to the contrary in the specifications.

Except as amended by this Addendum, all terms and conditions of the IFB remain unchanged.

Please Note: The format for this addendum will detail questions asked, answers given and clarifications and statements made. Q = Question, A = Answer, C = Clarification and S = Statement.

Q1: Will the county be providing the Type 2 Rock Blanket and the Type 3 Rock Ditch Liner? A1: a. Per the Spec - 609.60.5.4 If the plans do not provide for a source of material, the contractor shall provide the material. All costs for securing the source, quarrying, excavating, breaking and hauling the material to the site will be paid for at the contract unit price for Furnishing Rock Ditch Liner.

b. There will be a Furnishing Type 2 Rock Blanket quantity and a Placing Type 3 Rock Ditch Liner quantity for both projects.

- i. 148<sup>th</sup> St Project Furnishing Type 2 Rock Blanket 442 CU YD
- ii. 148<sup>th</sup> St Project Placing Type 2 Rock Blanket 442 CU YD
- iii. 148<sup>th</sup> St Project Furnishing Type 3 Rock Ditch Liner 40 CU YD
- iv. 148<sup>th</sup> St Project Placing Type 3 Rock Ditch Liner 40 CU YD

**Q2**: Who is providing the Geo textile fabric that is on sheet 24?

A2: Geotextile Fabric will be provided by the contractor. See the Spec on Rock Blanket and Rock
Ditch liner. There will be a Permanent Erosion Control Geotextile quantity for both projects
i. 148<sup>th</sup> St Project - Permanent Erosion Control Geotextile – 783 SQ YD

Q3: What about road signs, there is no line item for them?

**A3**: The only signs on the project can be found on Sheet 7 of the 148<sup>th</sup> St and 188<sup>th</sup> St project. The quantities for those items (FLAT SHEET & WOOD POST 4X4) can be found on sheets 13 of the 148<sup>th</sup> St and 188<sup>th</sup> St projects.

Q4: What about road closed movable barricades, etc?

A4 From the plan cover sheet. The County will maintain the SIGNAGE (reflectivity, etc.). The Contractor checks the devices daily to maintain the CLOSURE OF THE ROAD. When the construction is over, the County will pick up their property.

# THE ROUTE, 148TH STREET, IS CURRENTL BY THE COUNTY AND WILL REMAIN CLOSED CONSTRUCTION, THE COUNTY SHALL MAINT ROAD CLOSURE SIGNAGE. THE CONTRACTOR CHECK THESE DEVICES DAILY TO MAINTAI CLOSURE OF THE ROAD.
