Bids are invited for the completion of work as follows:

Work will include the installation of a new railroad siding adjacent to the existing Pemiscot County Port rail as shown on the plans. The project "Base Bid" will include the correction of approximately 1,950 square yards of existing subballast and the installation of approximately 1,175 feet of new storage rail adjacent to the existing Pemiscot County Port main rail. In the "Base Bid" the Owner will provide the following materials at a storage area approximately 0.5 miles from the project site; #140 rail, wood ties, other track material, crossing panels, geotextile fabric, subballast and ballast. The contractor will be responsible for material loading, hauling/delivery and proper installation of the new storage rail. The "Base Bid" also includes the contractors lining, surfacing and tamping of approximately 5,000 track feet of existing Port Authority rail with the owner providing necessary ballast material as previously noted. An "Alternate Bid" is requested for the contractor to furnish #140 rail, wood ties, other track material, and crossing panels as required to construct the new rail storage track. The "Alternate Bid" also requests additional lining, surfacing and tamping of up to 10,000 track feet of existing Port Authority rail with the owner providing necessary ballast material as previously noted.

In evaluating these factors, the Owner will necessarily consider and compare (relative to the other bidders) the experience of the bidder on this type of project or similar projects, <u>AND</u> the performance history of the bidder regarding conformity with specifications, meeting terms of delivery and quality of work <u>AND</u> the performance history and ability of the bidder to complete the project on time, to service the product (including response time to service calls) and workmanship on the project.
