

INVITATION TO BID

Sealed proposals for the improvements of the **NELSON DRIVE SIDEWALK IMPROVEMENTS**, will be received by the CITY OF NORTHWOODS, Northwoods, Missouri, at Northwoods City Hall office located at 4600 Oakridge Blvd. on **May 4, 2020 at 11:00 am**. Due to current public health concerns, submit bids in PDF electronic file format. All bids shall be submitted by Email Transmittal; subject line to Include “**NELSON DRIVE SIDEWALK IMPROVEMENTS (Bid Submittal)**”. Email submittals received by the City of Northwoods after said time will not be considered.

The proposed work includes the furnishing of materials, tools, equipment and labor necessary for the construction of approximately 0.41 miles of sidewalk and reconstruction of driveway aprons in accordance with the plans and specifications and other items identified in the contract documents. The contractor is responsible for all items of work necessary to complete the project.

Due to the Coronavirus only digital copies of the plans and specifications may be obtained on April 10, 2020 from WEIS DESIGN GROUP, 16296 Westwoods Business Park Dr., Ellisville, MO. 63021 upon a deposit of **Thirty Dollars (\$30.00)** for each set. The deposit will be not be non-refundable.

Each bid must be accompanied by a cashier's check or certified check, or a Bid Bond executed by the BIDDER and an approved surety company and payable to the CITY, in an amount not less than five percent (5%) of the sum total of the base bid.

Not less than the prevailing hourly rates of wages that the higher of State or Federal Wage Rates shall prevail, or determined by court on appeal, shall be paid to all workers performing work under this Contract.

The DBE goal for this letting is a minimum **16%** of the total contract amount.

All BIDDERS must meet the MoDOT requirements as a CONTRACTOR prior to bid opening in accordance with the Missouri Standard Specification Book for Highway Construction.

A Performance Bond and Payment and Materials Bond are required.

The City of Northwoods hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award.” color, or national origin in consideration for an award.

In accordance with the Davis-Bacon Act, and the Missouri Prevailing Wage Law, the Contractor will be required to comply with the wage and labor requirements and to pay minimum wages in accordance with the schedule of wage rates established by the United States Department of Labor and the Missouri Division of Labor Standards, respectively. The highest rate between the two (Federal and State) for each job classification shall be considered the prevailing wage.
