#### 1. Introductions

- **a.** In-person attendees and video conference attendees that self-identified are listed on the attached sign-in sheet.
- b. Video Callers were asked to
  - i. Mute audio & turn off your cameras.
  - ii. Click chat to send written questions at any time.
  - iii. Indicate the company that you represent.
- **c.** The meeting was paused at the end of each major topic to allow participants to ask questions during the meeting.
- **d.** Plan holders list (as of this morning) is attached. Updates can be obtained from www.questcdn.com if you've purchased the project plans on that website. (Quest project number 6668753) or by contacting Joyce Ewing jewing@olsson.com

#### 2. Design changes since the February advertisement, which was cancelled.

- a. Incorporated addenda issued for the February 18 bid letting.
- **b.** Crack & Seat option to leave runway pavement in place is included, but pavement removal is still an option.
  - i. Bid Item 8 is Crack & Seat or Concrete Pavement Removal. Bidder does not need to identify which one they plan to do.
  - ii. Bid Item 15 Embankment in Place has 2 options. If pavement is removed, then additional embankment is needed to fill the void where the pavement was. If pavement is not removed, then the quantity is lower.
  - iii. Bid Item 7 Concrete Pavement Removal is still required for taxiway, turnaround and apron.
  - iv. Previous bid item for Asphalt Removal has been deleted. Asphalt removal is subsidiary to concrete removal. Based on the pavement history, it is highly likely that there is no asphalt under portions of the concrete, but exact extents of asphalt are unknown.
- c. Third off-site geotechnical testing report added. The owners of these properties are not identified in the bid documents. The engineer will provide names and phone numbers upon request. Call or email Diane Hofer to receive this information. Contact information is provided on the sign-in sheet or bid documents.
- **3. Project Overview.** An exhibit showing the overall project with an aerial background is attached.
  - a. Base Bid. Remove/replace or crack/seat/replace runway, which will be shifted south and raised 3'-6'; remove taxiway & replace in new location; install edge lights, PAPIs, REILs & new electrical vault
  - b. Alternate 1. Hammerhead turnaround with lights
  - c. Alternate 2. Loop turnaround with lights

d. Contract award (Ref. Gen. Prov. 30-02). If the Owner elects to proceed with an award of contract, the Owner will make the award to the combination that is within the available tentative allocation and is the lowest responsive proposal for that combination. Three combinations will be evaluated: 1) Base Bid; 2) Base Bid plus Alternate 1; and 3) Base Bid plus Alternate 2. Note that the tentative allocation amount includes all of the following: construction, engineering, wetland permit costs, PAPI purchase, and FAA flight check.

# 4. Schedule

- **a. 220 Calendar Days for the base bid**; 240 CD for base + alternate 1; and 250 CD for base + alternate 2. Requests for additional days will not be considered after the bid opening.
- **b.** Notice to Proceed will be issued September 14, 2020, at which time the airport will be closed.
- **c. Grading completion**. Olsson estimates grading to be completed by mid to late December 2020
- **d.** Settlement plates (Ref. Sheet 14). Olsson will install and monitor these. Contractor to cut flush with subgrade and fill with CLSM prior to placing base course.
- e. Settlement period is 45-60 days; then wait for weather in Spring
- f. Maintenance of erosion control & barricades during shutdown will be required.
- g. Recompaction of subgrade required at spring start up
- **h.** Electrical vault may begin in fall, but only after settlement period for SP-1. No work during shutdown
- i. **Project Completion.** Assuming April 5, 2021 start-up, Olsson estimates project completion by late July to August 2021.
- j. Liquidated Damages are established at \$3,225 per calendar day.

# 5. Funding

- **a. Grant conditions**. The grant funds are limited and overruns during construction will create extreme difficulties with funding. Every effort has been made to ensure quantities are adequately estimated and to avoid overruns during construction.
- b. Estimated quantities that may underrun:
  - i. Grading
    - 1. **Irregularities.** A quantity for irregularities is listed to avoid unforeseen circumstances. See tables on Sheet 3 of plans. The irregularities were calculated at 10 percent of in-place embankment. However, it is highly likely that the irregularities will not be needed and thus will not be paid.
    - 2. **Muck.** A pay item for muck is included but will be paid for only as necessary and agreed upon at the time of construction. Muck excavation quantity was calculated at approximately 10 percent of the subgrade preparation area.
  - ii. **Recycled concrete & geogrid** (bid items 18 & 19) are included for unforeseen circumstances. The geotechnical exploration report did not find any areas that require over-excavation. However, if unsuitable material is found during construction and if directed by the engineer and RPR, this material may be used to improve constructability. This material will not be paid if not directed by the Engineer.
- c. Estimated construction cost is \$6-\$8 million

# 6. Existing Conditions

- **a.** Runway is concrete partially over asphalt. The original asphalt runway was shown on historical plans as approximately 40' wide. The south end of the runway is not likely underlaid with asphalt.
- **b.** Water table is high. Dewatering is subsidiary.
- **c.** Wetlands will be impacted in several areas of the project and the city has obtained a Corps of Engineers permit for this impact. Wetland areas that are not to be disturbed are shown on the plans.
- d. Off-site borrow. See attached exhibit for locations. Three potential sites were identified prior to the meeting and tests have been conducted on these sites.
  - i. Geotechnical reports are included in the bid documents in Appendix B. In the pdf version of "Bid Doc-Specification K57 18-001A-1A", the appendix starts on pdf page 509.
  - ii. Contact info for all three sites is available and may be obtained from Diane Hofer, PE, Project Engineer at dhofer@olsson.com
  - iii. Limit truck weight to legal limits
- e. Existing crops on airport property will be soybeans. Restrict construction limits to avoid unnecessary damage to the crops.

# 7. Safety Plan

- a. Access points & haul routes are shown on the plans and were discussed
- **b. MoDOT access permits** (Ref. Local Provisions para. 21). Olsson has coordinated with MoDOT, however, the Contractor is responsible for obtaining an Entrance Permit and a Utility/Communication permit from the NW District of the Missouri Department of Transportation. See Local Provisions para. 21 for contact information and additional information.
- c. Tarkio Special Road District. Contact Randy Freeman for haul route requirements
  - i. (660) 744-4606 (work)
  - ii. (660) 623-2001 (personal)
  - iii. Any modifications to haul routes within Tarkio Special Road District must be restored to existing conditions or better upon project completion, at the contractor's cost. The Tarkio Special Road District will have no resources to assist with maintenance or improvement of haul routes.
- **d. Waste Disposal.** Atchison County Highway Department may accept pavement that has been removed from the airport.

- e. Storage areas are shown on the plans. If additional areas are needed, contact the city to discuss leasing arrangements.
- f. Contractor's Safety Plan Compliance Document (SPCD) (Ref. Local Provision 10)

### 8. Specifications to Note

- a. Proposal submittal is pages PF-1 thru PF-17 only (Ref. Gen. Prov. 20-07). Submittal of the entire contract book is not required.
- **b.** FAA's Specifications 5370-10H, issued 12/21/18 were used for this project.
- c. Survey. Contractor's responsibilities (Ref. Gen. Prov. 50-07)
  - i. Survey of surface tolerance on subgrade and base course (50' x 50' grid) (Ref: P-152-2.13 & P-209-3.8)
- d. Aggregate Base Course materials can be either P-209 or P-208
- e. Marking: Reflectometer is new requirement (P-620-3.8). One source is Professional Pavement Products (904) 509-6442

# 9. Electrical Work

- **a. PAPI units pre-purchased by City**. Bid items 62 and 63 are for installation only, and shall include concrete foundations, junction cans, cables, etc. and all appurtenances.
- **b. REILs** to include baffles for pricing.
- c. Concrete for Light Bases, Junction Cans and New Vault. Contractor can use MoDOT concrete for small quantities, which may be useful if the electrical subcontractor is working prior to the production of P-501 concrete.
- d. Existing vault (Ref. Sheet 62)
  - i. Remove regulators but leave meter cabinet
  - ii. Reconnect existing beacon
  - iii. Maintain service to existing facilities
- e. Service to new vault shall be at the contractor's expense.

### **10. Other Provisions of Note**

- a. Contractor Quality Control Program for P-501 Concrete Pavement is required. Note the requirements for a mix design include an accredited lab and signature of a professional engineer.
