Sealed bids for Public Improvements for, Hunt Road Sidewalk, will be received at: City Hall, 224 W. Jackson, Willard, Missouri, 65781 until 2:00 PM (Prevailing Local Time) on the 5th day of June 2020 and at that time will be publicly opened and read. The envelopes containing the bids must be sealed, addressed to the **City of Willard, 224 W. Jackson, Willard, Missouri** and designated as bid for **PUBLIC IMPROVEMENTS FOR, HUNT ROAD SIDEWALK**. Due to the development of COVID-19, the bids will be publicly opened and read aloud via teleconference call. The bid opening can be accessed by dialing **1-570-915-0092** and entering pin number: **858653750#**.

The proposed work includes: The construction of sidewalk along Hunt Rd. beginning approximately 325' north of Truman Rd along the east side of Hunt Rd. The sidewalk crosses over to the west side of Hunt Rd and then parallels Hunt Rd to the end point of the parking area approximately 575' south of Becky St. The work will include sidewalk, ramps, driveway reconstruction, and all other miscellaneous work required for completion of the project.

All labor used in the construction of this public improvement shall be paid a wage no less than the prevailing hourly rate of wages of work of a similar character in this locality as established by the Department of Labor and Industrial Relations (Federal Wage Rate), or state wage rate, whichever is higher.

The City of Willard hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award.”

All bidders must be on MoDOT’s Qualified Contractor List per Section 102.2 of the Missouri Standard Specifications for Highway Construction, 2011 Edition including all revisions. The contractor questionnaire must be on file 7 days prior to bid opening.

Contractors and sub-contractors who sign a contract to work on public works project provide a 10-Hour OSHA construction safety program, or similar program approved by the Department of Labor and Industrial Relations, to be completed by their on-site employees within seventy (70) calendar days of beginning work on the

construction project. No matter what date the contractor chooses to begin the project, the project must be completed on or before October 16, 2020.

A certified or cashier's check or a bid bond in the amount of 5% shall be submitted with each proposal.

The City of Willard reserves the right to reject any or all bids.

The DBE Goal for this project is 0%.

No 2nd tier subcontracting will be allowed on this project.
