Mid-America Regional Council (MARC) will receive sealed bids at: **MoDOT / Operation Green Light Traffic Center until 2:00 P.M. on the 28th day of August 2020**, at the office of Mid-America Regional Council Traffic Operations Center, 600 NE Colbern Rd. Lee's Summit, MO 64086. Bids won't be publicly opened and read aloud due to COVID-19, but there will be a teleconference bid opening on August 28, 2020 at 3:00 P.M. Call in information can be obtained by contacting Ray Webb. All bids shall be submitted in the form of paper bids, with all forms and sheets submitted as stated within the bid package.

The work under this contract shall consist of the installation of a radar detection system along US-71 with the purpose of implementing a traffic responsive system to improve traffic movement along the corridor. Bidders must bid on the project as a whole. The Mid-America Regional Council (MARC) Operation Green Light (OGL) Program is bidding the project. The project shall follow the latest edition of MoDOT standards and Missouri Standard Specifications for Highway Construction and these Job Special Provisions. MARC will award the project to a single contractor.

All Bids must be in accordance with the Bidding Documents on file at the Drexel Technologies. All labor used in the construction of this public improvement shall be paid a wage no less than the prevailing hourly rate of wages of work of a similar character in this locality as established by the Department of Labor and Industrial Relations (Federal Wage Rate), or state wage rate, whichever is higher.

The Mid-America Regional Council hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award."

All bidders must be on MoDOT's Qualified Contractor List per Section 102.2 of the Missouri Standard Specifications for Highway Construction, 2011 Edition including all revisions. The contractor questionnaire must be on file 7 days prior to bid opening.

A certified or cashier's check or a bid bond in the amount of 5% shall be submitted with each proposal. The Mid-America Regional Council reserves the right to reject any or all bids. The DBE Goal for this project is 0%. For more information contact:
