

## ADVERTISEMENT FOR BID

Pedestrian Bridge over Blue Branch Creek

RFP: 2020-04

Federal TAP Project No.3356(406), City of Grain Valley, MO

Sealed bids shall be endorsed "Proposal" for constructing Pedestrian Bridge over Blue Branch Creek, Cross Creek Park, and will be received by the City of Grain Valley until 2 o'clock p.m. (Central Standard Time) on the 1<sup>st</sup> day of October, 2020 at 711 NE Main St. Grain Valley, MO. Bids will NOT be accepted after this date and time under any circumstances. Due to Co-Vid 19 Protocols there will be no in-person public opening of Bids. The bids will be publicly opened and read aloud via Zoom Meeting with a date and time to be established in a forthcoming Addendum.

The project is generally described as: Bridge Demolition, Grading, Constructing a 95' Pratt Steel Truss Span, and a 10'-0" Trail where it crosses over Blue Branch Creek in Cross Creek Park, including all incidental work in accordance with the plans and specifications.

All labor used in the construction of this public improvement shall be paid a wage no less than the prevailing hourly rate of wages of work of a similar character in this locality as established by the Department of Labor and Industrial Relations (Federal Wage Rate), or state wage rate, whichever is higher.

The City of Grain Valley hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award."

All bidders must be on MoDOT's Qualified Contractor List per Section 102.2 from the current version of the Missouri Standard Specifications for Highway Construction, including all revisions. The contractor questionnaire must be on file 7 days prior to bid opening.

Contractors and sub-contractors who sign a contract to work on public works project provide a 10-Hour OSHA construction safety program, or similar program approved by the Department of Labor and Industrial Relations, to be completed by their on-site employees within sixty (60) days of beginning work on the construction project.

A certified or cashier's check or a bid bond in the amount of 5% shall be submitted with each proposal.

The City of Grain Valley reserves the right to reject any or all bids.

**The DBE Goal for this project is 7%.**

No 2<sup>nd</sup> tier subcontracting will be allowed on this project.
