For work performed anywhere on this project, the contractor and the contractor's subcontractors shall pay the higher of these two applicable wage rates. The applicable state wage rates for this contract are detailed in "Annual Wage Order No. 27", that is attached to this bidding document. (17) **PROJECT AWARD:** This project will be awarded to the lowest, responsible bidder.

(18) **PRIME CONTRACTOR REQUIREMENTS:** In accordance with Federal Highway Administration's rule at Title 23 Code of Federal Regulations (CFR) § 635.116(a), the contractor must perform project work with its own organization equal to and not less than 30 percent of the total original contract price. Second-tier subcontracting will not be permitted on this contract. All other provisions in Sec 108.1.1 et seq. of the Missouri Standard Specifications for Highway Construction shall remain in full force and effect, and shall continue to govern the contractor and its subcontractors, in accordance with the provisions of Title 23 CFR § 635.116.

(19) <u>SALES AND USE TAX EXEMPTION</u>: The City of Kansas City, Missouri, a tax exempt entity, will furnish a Missouri Project Exemption Certificate as described in Section 144.062 RSMo to the awarded contractor who in turn may use the certificate to purchase materials for a specific project performed for the tax exempt entity.
