Not less than the prevailing hourly rate of wages shall be paid to all workers performing under this Contract in this area according to the rates determined by the Department of Labor and Industrial Relations of the State of Missouri. The latest Annual Wage Order shall be used at time of Work is completed.

The City of Richmond Heights hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award."

All bidders must be on MoDOT's Qualified Contractor List per Section 102.2 from the current version of the Missouri Standard Specifications for Highway Construction, including all revisions. The contractor questionnaire must be on file 7 days prior to bid opening.

Contractors and sub-contractors who sign a contract to work on public works project provide a 10-Hour OSHA construction safety program, or similar program approved by the Department of Labor and Industrial Relations, to be completed by their on-site employees within sixty (60) days of beginning work on the construction project.

A certified or cashier's check or a bid bond in the amount of 5% shall be submitted with each proposal.

The DBE goal for this letting is a minimum of 16% of the total contract amount.

The City of Richmond Heights is a tax exempt entitiy. A project exemption certificate will be supplied to the successful bidder.

The City reserves the right to accept or reject any bid and to waive any irregularities in the best interest of the City.

After reviewing all bids and receiving approval from MODOT, the project will be awarded to the lowest, responsible bidder.

No 2<sup>nd</sup> tier subcontracting will be allowed on this project.
