The Jefferson County Department of Public Works is requesting the services of a consulting engineering firm to perform the described professional services for the project included on the attached list. If your firm would like to be considered for these consulting services, you may express your interest by responding to the appropriate office, which is indicated on the attachments. Limit your Letter of Interest (LOI) to no more than five (5) pages. This LOI should include any information which might help us in the selection process, such as the persons or team you would assign to each project, the backgrounds of those individuals, and other projects your company has recently completed or are now active. It is required that your firm's Statement of Qualification (SOQ) (RSMo 8.285 through 8.291) be submitted with your firm's LOI, or be on file with the Jefferson County Department of Public Works. The SOQ is not included in the total page count limit for the LOI. Please do not send Jefferson County five (5) copies of your SOQ.

DBE firms must be listed in the MRCC DBE Directory located on MoDOT's website at www.modot.gov, in order to be counted as participation towards an established DBE Goal. We encourage DBE firms to submit letters of interest as prime consultants for any project they feel can be managed by their firm.

It is required that your firm <u>be</u> prequalified with MoDOT and listed in <u>MoDOT's Approved Consultant Prequalification List</u>, or your firm will be considered non-responsive.

We request that four (4) copies of your LOI be received by 4:00 pm on Friday, December 18, 2020, at the Jefferson County Department of Public Works, 725 Maple Street, Hillsboro, Missouri 63050.
