Sealed proposals and bids will be received by TransPort 360, LLC until 10:00 a.m. (Prevailing Local Time) on the 2<sup>nd</sup> day of April, 2021, at the office of the St. Joseph Chamber of Commerce, 3003 Frederick Avenue, St. Joseph, Missouri 64506, and at that time will be publicly opened and read.

### **Work by Contractor**

Work by contractor to include:

Driving HP 10'x42' piling to practical refusal as shown on the plans and specifications.

### **Work by TransPort 360**

Work by TransPort 360 shall include:

Construction of two new 14'x45' (approximately) hopper bins, overhead transfer conveyor, under bin transfer conveyor, drag paddle conveyor and pit. River bank stabilization and concrete pad for a pivoting extendable conveyor and associated sitework. Bid for TransPort 360 work shall include the manufacturing, delivery, assembly and installation of the following equipment.

- #6 Hopper Bins
- #7 TeleStacker
- #9 Alternate No. 2 – Drag Paddle Conveyor
- #10 Alternate No. 3 – Overhead Conveyor, Support Tower and Chute
- #11 Alternate No. 4 – Under Bin Conveyors
- #12 Alternate No. 5 – 3<sup>rd</sup> Hopper Bin & Conveyor

The wage rates applicable to this project have been predetermined as required by the law and are set forth in the bid proposal.

A Pre-Bid conference will be held at the St. Joseph Regional Port Authority located at 1616 Stockyards Expressway, St. Joseph, Missouri 64501 on Tuesday, March 23<sup>rd</sup>, 2021 at 10:00 a.m. Pre-Bid is not mandatory but is highly encouraged.

The St. Joseph Regional Port Authority hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to

this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award.

Plans and specifications may be inspected at the St. Joseph Regional Port Authority and complete instructions of bidders and proposal blanks may be obtained from Snyder & Associates at 802 Francis, St. Joseph, MO 64501 (816.364.5222) upon the receipt of Forty dollars (\$40.00). **Payment is non-refundable.** Only contractors who have paid for plans and specifications and are listed on the plan holders list will be eligible to bid.

Missouri Law, 292.675 RSMO, requires the awarded Contractor and its subcontractor(s) to provide a ten-hour occupational safety and health administration (OSHA) construction safety program (or a similar program approved by the Missouri Department of Labor and Industrial Relations as a qualified substitute) for their on-site employees (laborers, workmen, drivers, equipment operators, and craftsmen) who have not previously completed such a program and are directly engaged in actual construction of the improvement (or working at a nearby or adjacent facility used for construction of the improvement).

The awarded Contractor and its subcontractor(s) shall require all such employees to complete this ten-hour program, pursuant to 292.675 RSMO, unless they hold documentation on their prior completion of said program. Penalties for non-compliance include Contractor forfeiture to the Missouri Highways and Transportation Commission in the amount of \$2,500, plus \$100 per Contractor and sub-contractor employee for each calendar day such employee is employed beyond the elapsed time period for required program completion under 292.675 RSMO.

The project will be awarded to the lowest, responsive, responsible bidder. Bidders must be on MoDOT's pre-approved contractor list.

Proposals must be on forms provided in the Specifications and Contract Documents. The right is reserved to reject any or all bids.
