The proposed work includes:

Construction of a new 45 foot slab beam bridge at north bridge location and construction of a new 55 foot slab beam bridge at south bridge location, approach roadway work, and any incidental work in accordance with the plans and specifications. The project is located on Delbridge road, Section 21, Township 36 N & Range 2 E, Washington County, Missouri, over Clear Creek.

A certified cashier's check or a bid bond in the amount of 5% shall be submitted with each proposal.

The project will be awarded to the lowest, responsive, responsible bidder.
