## [I-70 Lake St. Louis Blvd. Interchange Roundabout](#)

Crews began the first portion of the project closures on Wednesday, May 19. The contractor closed a portion of Veterans Memorial Parkway, located from Lake St. Louis Boulevard to east of Rue Petite Drive.

There will be a two-mile detour in place. Motorists can take Lake Saint Louis Boulevard to Bent Oak Cutoff Drive and back to Veterans Memorial Parkway. The closure will be in place until Late July.

## [I-70 Lake St. Louis Blvd. to Route K Pavement Improvements](#)

Work has begun on the section of I-70 pavement improvement project between Lake Saint Louis Blvd. and Route K. Crews have started performing full-depth pavement repairs. They will follow up with a removal and asphalt resurfacing of the two outside lanes as the project progresses into the summer months.

In addition to the asphalt, the contractor will work in the inside (fast lanes) to make some repairs to the concrete driving

The rehabilitation of the Eastbound Blanchette Bridge truss was substantially complete last November, but some epoxy deck sealing does remain for the driving surface. Due to an unforeseen nationwide material supply issue, the final application schedule is uncertain at this time.

A tentative work schedule will be provided once the epoxy material becomes available again.
