MINUTES OF THE HIGHWAYS AND TRANSPORTATION COMMISSION MEETING HELD VIA TELECONFERENCE AND IN JEFFERSON CITY, MISSOURI, MONDAY, JUNE 14, 2021

A meeting of the Missouri Highways and Transportation Commission was held on Monday, June 14, 2021, via teleconference and at the Missouri Department of Transportation, 105 W. Capitol Ave, Jefferson City, Missouri. Michael T. Waters, Jr., Chair, called the meeting to order at 9:00 a.m. The following Commissioners were present: John W. Briscoe, Gregg C. Smith, Terry L. Ecker, Robert G. Brinkmann, P.E., and W. Dustin Boatwright, P.E.

The meeting was called pursuant to Section 226.120 of the Revised Statutes of Missouri, as amended.
