Bridge Replacement Work
Notice to Bidders**

SEALED PROPOSALS consisting of:

**Osage County – CR 531 Bridge Improvements
Federal Aid Project No. BRO-B0-76(15)**

Located along County Road 531 over School Hollow Branch in Osage County, Missouri.

Bids will be received and opened publicly at the office of the Osage County Office, 205 East Main Street, Linn, MO 65051 at, **9:00 A.M. on 20th September, 2018.**

Any and all bids received after the time specified above will be returned unopened.

The proposed work involves replacing the County Road 531 vehicular-bridge crossing at School Hollow Branch with a two-span bridge 100' in length and will utilize MODOT type II girders. The current wall abutment will be removed, and will be replaced with a spill-slope style bridge (2' rock blanket) with an end bent supported by piles. The intermediate bent will be pile supported in approximately the same location as the existing bridge. For the span of time when the bridge is under construction, there will be a temporary bypass road constructed to the west which will provide access for local residents, as well as emergency vehicles. It is proposed that the bypass road will have 3 - 48" diameter CMPs to pass low volume flows. All equipment, material and workmanship must be in accordance with the plans, specifications, and contract documents on file with Osage County.

All labor used in the construction of this public improvement shall be paid a wage no less than the prevailing hourly rate of wages of work of a similar character in this locality as established by the Department of Labor and Industrial Relations (Federal Wage Rate), or state wage rate, whichever is higher.

Osage County hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award.

All bidders must be on MoDOT's Qualified Contractor List per Section 102.2 of the Missouri Standard Specifications for Highway Construction, 2017 Edition including all revisions. The contractor questionnaire must be on file 7 days prior to bid opening.

Contractors and sub-contractors who sign a contract to work on public works projects must provide a 10-Hour OSHA construction safety program, or similar program approved by the Department of Labor and Industrial Relations, to be completed by their on-site employees within sixty (60) days of beginning work on the construction project.

Proposals must be on forms provided.

The project will be awarded to the lowest, responsive, responsible bidder.
