The City of Florissant, MO is seeking proposals from qualified contractors for the **Robinwood Elementary Pedestrian Signal Project, STP-5595(615)** (the “Project”) in the City of Florissant, Missouri. Sealed bids clearly marked as “**BID OPENING: ROBINWOOD ELEMENTARY PEDESTRIAN SIGNAL PROJECT- ATTENTION CITY ENGINEER.**”, addressed to: Florissant Public Works, 955 Rue St. Francois, Florissant, Missouri 63031 will be accepted by the City of Florissant until **2:00 P.M. (prevailing local time) on the 24<sup>th</sup> day of October 2018** at which time all bids received will be opened and read aloud.

All labor used in the construction of this public improvement shall be paid a wage no less than the prevailing hourly rate of wages of work of a similar character in this locality as established by the Department of Labor and Industrial Relations (Federal Wage Rate), or state wage rate, whichever is higher.

The City of Florissant hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award.

All bidders must be on MoDOT’s Qualified Contractor List per Section 102.2 of the Missouri Standard Specifications for Highway Construction, 2017 Edition including all revisions. The contractor questionnaire must be on file 7 days prior to bid opening.

Contractors and sub-contractors who sign a contract to work on public works project shall provide a 10-Hour OSHA construction safety program, or similar program approved by the Department of Labor and Industrial Relations, to be completed by their on-site employees within sixty (60) days of beginning work on the construction project.

A certified or cashier’s check or a bid bond in the amount of 5% shall be submitted with each proposal.

The City of Florissant reserves the right to reject any or all bids, in whole or in part, and to waive any irregularities with regard to the bidding process. If a contract is made, the project will be awarded to the lowest, responsive, responsible Bidder based on the sole determination of the City of Florissant.

The DBE Goal for this project is **15%**.

No 2nd tier subcontracting will be allowed on this project.

The City intends to issue a notice to proceed in the fall of 2018.
