Mrs. Angela A. Long, 91, of near De Soto, widow of Judge James J. Long, who was justice of the peace in Platte Township for many years, died of infirmities at 1:30 a.m. today at Wood nursing home, Route JJ, near De Soto, where she had been a patient for two months. She has 88 living direct descendants.

Mrs. Long made her home with a son, Gilbert J. Long, county juvenile officer, until entering the nursing home. A resident of Jefferson county since 1933, she was born in St. Louis, November 6, 1876, daughter of the late John and Ann Padberg. A son Oliver, preceded her in death.

A devout Catholic, Mrs. Long was a member of the St. Rose of Lima church, St. Ann's sodality, and the Daughters of Isabella.

Survivors besides her son Gilbert are two other sons, Vincent J. Long of Greenwich, Conn., and Frank E. Long of Las Vegas, Nev., a daughter, Mrs. Angela Weber, of Crestwood; two sisters, Mrs. Agnes Lucas and Mrs. Hilda Killoran, both of St. Louis; 23 grandchildren; 60 great-grandchildren; and a great-great-grandson.
