# Roundabout at US 61 / MO 161 / Court St.

The City of Bowling Green and MoDOT are splitting the nearly \$1.4 million cost of an intersection Improvement at the "crossroads" in town – U.S. 61/ MO 161 and Court Street in Bowling Green. This will include a roundabout intersection, the repalcement of an existing box culvert and new street lighting at this locaton. The contract was awarded to Bleigh Construction Company and is expected begin later this spring/early summer.

This project will replace the existing four-way stop on Business 61/Court Street and MO 161. The current intersection has a level of service rating of "F" and causes significant delays and backups multiple times a day, especially when school lets out. The delays impact access to the businesses at the intersection and overall congestion. The new roundabout intersection will improve the level of service rating to "A". Motorists will see reduced traffic delays compared to the existing four-way stop, in addition to increased safety and improved access to nearby businesses during peak traffic times.

There will be four traffic control phases throughout the project, one which includes the closure of MO 161 for up to 70 days. The City is working with businesses, property owners, and local residents, to keep everyone informed throughout the project.




Did you know..... Roundabouts = 25-year service life Signal equipment = 15-year service life



### Four Phases of Construction/Traffic Control

- 1. Phase 1 will include constructing a temporary widening along the north side of Business 61.
- 2. Phase 2 will include closing of the south side of the intersection and Missouri Route 161. The closure is expected to last up to 70 days; should the contractor go over 70 days, their contact specifies they will have to pay penalties.
- 3. Phase 3 will include the reopening of Missouri Route 161, and the closure of Court Street for the construction of the north side of the roundabout. This closure is expected to last up to 45 days.
- 4. Phase 4 has all lanes open and includes pavement markings and concrete islands. This is designated as night work.



Roundabouts are proven to be safer by requiring driving 25 mph or slower giving drivers more reaction time to other vehicles or pedestrians in crosswalks.

## **Temporary Closure of MO 161**

- Increased safety for workers and drivers
- Traffic signal option adds \$100,000 to project (not feasible)
- Keeping it open adds several days to project and increased costs
- Up to 70 days (Contractor penalties if past 70 days)
- State signed detour
- Modified detour for emergency vehicles only
