General Summary

The planning and programming coordinator supervises long range transportation planning, the statewide transportation improvement program (STIP), and statewide programming plan development. Responsibilities are performed under general supervision.

Minimum/Required Qualifications

- Bachelor's Degree: Accounting, Business Administration, Engineering, Finance, Planning, Public Administration, or related field, AND nine years of experience in transportation planning or engineering, OR
- Thirteen years of experience in transportation planning or engineering.

Special Working Conditions/Job Characteristics

Examples of Work

- 1. Directs administration of statewide programming, organizational performance, and Metropolitan Planning Organization (MPO)/Regional Planning Commission (RPC) planning work units.
- **2.** Educates department employees, the general public, and other stakeholders on transportation planning issues, processes, and projects.

- 3. Responds to planning and programming-related requests from districts, divisions, Federal Highway Administration, and state legislators; supervises report development for the media, elected officials, special interest groups, department management, and the general public.
- 4. Oversees development of the STIP, amendments to the STIP, and the STIP Accountability Report.
- **5.** Oversees and coordinates the department's organizational performance management system, including development of performance and measurement targets.
- **6.** Develops, implements, and updates long range transportation plans.
- 7. Oversees the integration of MPO work products with STIP products and processes.
- 8. Develops and tracks the section's budget and the State Planning and Research budget.
- **9.** Develops strategies to accomplish the department's transportation goals, including analyzing funding alternatives and legislative needs, and relationships with the general public, other organizations, cities, media, and the legislature; prepares related reports and correspondence; makes presentations on transportation planning.
- **10.** Establishes links between long range planning, asset management, STIP development, department measures, and national performance measures.
- **11.** Supervises statewide programming, organizational performance, and MPO/RPC planning employees, including making hiring and other employment-related decisions, assigning work, disciplining employees, and conducting performance management.
- **12**. Serves as department representative on policy, research, and technical advisory committees, or for multi-state or consultant transportation management.
- **13.** Performs supervisory responsibilities in a manner consistent with the department's Affirmative Action Program.
- **14.** Performs other responsibilities as required or assigned.
