General Summary	The assistant to the chief safety and operations officer - safety and emergency management is responsible for leading, managing, developing, and organizing the department's employee safety and health programs; ensuring compliance with federally mandated drug and alcohol testing programs; collaborating with districts and divisions to eliminate or reduce employee exposure to hazards in the department's various work environments; oversees the department's emergency management and incident response programs. Responsibilities are performed under general supervision.
Minimum/Required Qualifications	Bachelor's Degree: Emergency Management, Fire Management, Homeland Security, Law Enforcement Administration, or related field Certification as a Certified Safety Professional Over nine years of experience in areas related to safety, risk management, or emergency management.
Supervisory Responsibilities	Full Supervision
Location	Central Office - Safety and Emergency Response
Special Working Conditions/Job Characteristics	Job requires occasional, statewide, overnight travel.

Examples of Work

- (1) Works with appropriate districts and divisions to develop safety policies, rules, and regulations and related training programs.
- (2) Answers and interprets safety concerns, employee health concerns, drug and alcohol testing questions, and policy issues.
- (3) Oversees and monitors loss control investigations; reviews employee incidents, performs loss analysis, and develops preventative measures; identifies process changes that will improve employee safety and health.
- (4) Directs the evaluation and testing of safety equipment, products, and procedures.

- (5) Represents department and risk management on various national, state, and internal committees; attends and contributes to various quick action teams.
- (6) Develops training sessions and course materials for department personnel and safety partners regarding incident response management techniques.
- (7) Plans and coordinates statewide safety conferences for department staff and safety partners.
- (8) Serves as an emergency management liaison with districts, divisions, state and federal agencies, other states, and local partners.
- (9) Directs Central Office Emergency Operations Center including standard operating procedures, training, and coordination among incident management personnel.
- (10) Monitors transportation and infrastructure emergency management issues including security, medical, and weather-related issues.
- (11) Represents the department on state, federal and industry committees and teams to share best practices, and coordinate emergency activities and resource allocation.
- (12) Plans and coordinates disaster exercises to ensure the department is prepared for emergency incidents.
- (13) Supports Federal Emergency Management Agency and Federal Highway Administration relief funding projects and reimbursements relating to past declared disasters.
- (14) Performs supervisory responsibilities in a manner consistent with the department's Affirmative Action Program.
- (15) Performs other responsibilities as required or assigned.
