MINUTES OF THE REGULARLY SCHEDULED HIGHWAYS AND TRANSPORTATION COMMISSION MEETING HELD IN JEFFERSON CITY, MISSOURI, TUESDAY, MARCH 1, 2022

respectively. Chairman Brinkmann noted during even numbered years the Commission may choose

whether to rotate leadership positions. He reported the Commission decided not to rotate leadership

positions and keep current leadership in place.

#### **CONSENT AGENDA**

#### **Consent Agenda Process**

In order to make the most efficient use of Commission meeting time and to ensure Commission members are well informed on issues requiring their action, staff prepares and submits to the Commission members, in advance of their meeting, internal memoranda consisting of advice, opinions, and recommendations related to the items of the Commission meeting agenda. Those items considered by staff to be of a routine or non-controversial nature are placed on a consent agenda. During the meeting, items can be removed from the consent agenda at the request of any one Commission member. The items that are not removed from the consent agenda are approved with a single motion and unanimous vote by a quorum of the members.

Minutes reflecting approval of items on the consent agenda are singly reported herein and intermingled with minutes reflecting action on related subjects that were openly discussed. Reference to "consent agenda" is made in each minute approved via the process described in the paragraph above. Minutes reflecting action on items removed from the consent agenda and openly discussed reflect the open discussion and vote thereon.

### Consideration of March 1, 2022, Consent Agenda

No items were removed from the consent agenda. Upon motion by Commissioner Smith, seconded by Commissioner Waters, the consent agenda items were unanimously approved by a quorum of Commission members present.

#### COMMISSION COMMITTEES AND COMMISSION RELATED BOARDS

The Commission has two standing committees: Audit and Legislative. In addition, it elects Commission representatives to two boards: Missouri Transportation Finance Corporation Board of Directors and MoDOT and Patrol Employees' Retirement System Board of Trustees. The Chairman also

serves on the Missouri Coalition for Roadway Safety Executive Committee. The following committee and board reports were made during the March 1, 2022, meeting.

**Audit Committee** – Commissioner Brinkmann stated there is no report this month, and the next Audit Committee meeting is scheduled for April 2022.

Legislative Committee – Commissioner Briscoe reported, the start of this legislative session has been extremely unusual. Some of this may be due to the retirement of United States Senator Roy Blunt and the chain of politicians hoping to move up themselves. While the House has been active by conducting public hearings and debating some initiatives on the House floor, the Senate has all but hit a stalemate for the first 28 legislative days of session. This slowdown is a result of the Senate's inability to negotiate new congressional redistricting boundaries resulting from the latest census figures. These boundaries are important in preparation for this year's midterm election cycle. A lot of activity is currently taking place in the Capitol, just not a lot of legislation moving yet this session.

The Department and the Commission have introduced its 2023 budget to both the House Budget and Senate Appropriations Committees. Also, testimony was provided in opposition to the repeal of the 12.5-cent per gallon fuel tax that was passed during the 2021 session. There have been meetings with members of the legislature to explain the importance of implementing a market salary pay program, which will allow the department to attract and retain employees. Discussions have been held with elected officials that resulted in the filing of legislation to reduce distracted driving by disallowing cell phone usage when operating a motor vehicle.

Finally, the annual legislative spring break recess begins upon adjournment on March 14 and will last until March 18.

**Missouri Transportation Finance Corporation (MTFC)** – Commissioner Smith reported the board met yesterday and approved a loan to the City of Republic totaling \$4,200,000 to widen Route MM from Route 360 (James River Freeway) to Interstate 44. The next MTFC meeting will be in May.

**MoDOT and Patrol Employees' Retirement System (MPERS)** – Commissioner Boatwright reported the Board met on February 25, 2022. Colonel Olson was elected as the Chair, and Todd Tyler was elected as Vice-Chair of the board. The Chair also appointed board members to committees. Legislative proposals that have the potential to affect the plan plus the proposal the Board is pursuing were reviewed. Staff and the Governance Committee continue to work on the development of the strategic plan, mission statement, and values. The Chief Investment Officer and financial consultant, NEPC, reviewed investment performance.

Missouri Coalition for Roadway Safety Executive Committee – Commissioner Brinkmann stated the Missouri Coalition for Roadway Safety (MCRS) Executive Committee did not meet this month, but he provided some updates regarding the state of highway safety in Missouri. One of the core principles of the MCRS is that everyone has a role to play in keeping the roadways safe. This is true at a statewide level, but also within local communities. The primary goal of the seven regional coalitions is to share the Show-Me Zero message locally and encourage communities to participate by taking ownership in the mission. From city officials to schools and police departments, everyone has an opportunity to get involved. Commissioner Brinkmann played a video from the community of Harrisonville, Missouri that

showed a great example of a community coming together to improve the safety of roadways. Commissioner Brinkmann congratulated the Harrisonville Cares Coalition on a job well done.

#### **DIRECTOR'S REPORT**

During the March 1, 2022, Commission meeting, Director Patrick McKenna provided the following report:

<u>Safety</u> – The Director followed up on the MCRS report noting how impactful the City of Harrisonville's efforts have been. He also noted the continued efforts of the Buckle Up Phone Down (BUPD) program and the desire to continue to encourage that program in states across the nation. He reminded everyone it really is simple; buckle up and put your phone down when you are driving.

<u>Winter Operations</u> – The month of February is the shortest months of the year, but it packed a punch this year with winter weather. Three out of the four weeks included a major winter event with a variety of rain, sleet, freezing rain, ice, and snow. As storms varied in intensity across the state, Director McKenna was proud to watch the MoDOT team work together to shift people and trucks around to help cover harder hit areas of the state.

Overall, the MoDOT crews plowed approximately 2 million miles during February. The MoDOT Emergency Operations Center was active for 10 days of the month. During the month of February winter operations consumed more than half of the total winter budget, with nearly 86,000 tons of salt used and more than 780,000 gallons of salt brine. This year the department started the practice of holding a weather forecast call 48 hours in advance and that helped tremendously with the planning and shifting of resources. MoDOT did an outstanding job in a short but tiring month of work! The Director shared several of the comments received regarding winter operations and read the following comment. "I don't know if all the men and women who are plowing the roads will see this or not, but I just wanted to say thank you to all of you for clearing the roads during this storm. In a culture of negativity lately, I just want you to know how much you are appreciated. Thank you for all you do!"

<u>Annual Planning Partners Meeting</u> – MoDOT held the annual planning partners meeting virtually on February 16. There were more than 180 attendees. At this annual meeting, MoDOT provides financial forecast information, planning and policy updates, and updates about the State Transportation Improvement Program (STIP) process. Staff from the regional planning commissions and metropolitan planning organizations have the chance to ask questions and share updates with the MoDOT team.

The Director indicated his appreciation of the ongoing cooperation and collective planning with these regional partners to identify and prioritize the most important projects in the regions. The Draft STIP will be presented to the Commission at its May meeting and made available for a comment period before finalizing the document for the July Commission meeting.

The Director expressed concern regarding different proposals that have been made at the capitol that would impact the one-hundred-year history of the commission, a bipartisan group that that injects upon MoDOT a non-partisan project selection process that is vital and to reverse that history or harm that process would be a dark day for the state of Missouri if any of that passed.

He also reported on the department's work in collaboration with the planning partners to start preparing the updated unfunded needs list. A preliminary list has been prepared and the Director noted his appreciation for everyone's hard work to prepare that document.

Meritorious Safety Award – The Director was pleased to share a heroic story regarding a MoDOT St. Louis employee. Motorist Assistance Operator Aaron Hastings was patrolling his assigned route on Interstate 270 in St Louis on Wednesday, October 31. At approximately 5:30 p.m. he pulled behind what appeared to be a stranded vehicle on the right shoulder. The vehicle had three people inside; two of them were employees with the Missouri Department of Mental Health and the third person was a patient in their care. Mr. Hastings heard the patient saying combative things to the two state employees. He notified dispatch that he needed law enforcement assistance.

The patient broke free and attempted to run into the lanes of traffic on I-270 during rush hour. Mr. Hastings quickly restrained the patient and had to maintain this for 15 minutes until law enforcement arrived. The Director presented Mr. Hastings with a meritorious safety award for his life saving efforts to restrain the patient from running into traffic and from hurting the other state employees.

## **MODOT PRESENTATIONS**

#### MODOT AVIATION SECTION UPDATE

On behalf of the Director, Amy Ludwig, Administrator of Aviation, and Steve Stockam, Chair of the Aviation Advisory Committee, presented an overview of MoDOT's Aviation Section and recent federal funding opportunities for airports in the National Plan of Integrated Airport Systems, including Coronavirus Aid, Relief, and Economic Security Act funding, Coronavirus Response and Relief Supplemental Appropriations Act funding, and American Rescue Plan Act funding, as well as Airport infrastructure grants to airports. General information was presented regarding the Aviation Advisory Committee, which advises the department on aviation issues.

Missouri's state airport system includes 120 public use airports. Of those, 107 airports are publicly owned which makes them eligible to receive either federal and/or state funds from MoDOT. Out of those 107 airports, 76 are in the National Plan of Integrated Airport Systems (NPIAS) which makes them eligible to receive federal funding. Of the 76 NPIAS airports, there are 68 that receive the airport improvement funding from MoDOT through the state block grant program. There are 31 airports in Missouri that are not eligible for federal funds but are eligible for state aviation trust funds and that program is administered

by MoDOT. The state airport system is an economic engine for the state, supporting over 100,000 jobs, over \$3.1 billion in annual payroll, and an overall annual economic impact of \$11.1 billion.

MoDOT's aviation team include eight employees whose primary objective is to successfully administer the airport improvement program funding through the state block grant program and to administer state aviation trust funds. Missouri currently has 93 active projects at 61 airports. The estimated project costs are over \$120 million and that does not account for the COVID-19 relief funds administered as well.

Because of the profound impact that the COVID-19 pandemic had on the aviation industry, the federal government developed several funding programs to assist aviation. Ms. Ludwig reviewed three different COVID relief funding sources for airports since the start of the pandemic. The first program was called the Coronavirus Aid, Relief, and Economic Security Act (CARES Act), and Missouri received just over \$2.6 million for 68 airports. These funds could be used for a wide variety of projects and things that are not typically reimbursed such as operating costs and to match federal funds for projects. To date, MoDOT has reimbursed over 75 percent of those funds. The next source of funding received was through the Coronavirus Response and Relief Supplemental Appropriations Act (CRRSAA). Missouri received just over \$950,000 for 64 eligible airports. These funds have a narrower scope and can only be used for operating costs not for match on a federal project or other things. Efforts are underway to get those funds drawn down, but it is going a little more slowly and that program has reimbursed 30 percent of those funds. Under the American Rescue Plan Act (ARPA), Missouri received \$2.2 million for 64 airports. These funds can be used for operating costs as well. While MoDOT has those funds available, the appropriation authority has not been provided yet and anticipate that to be resolved in the next couple of months and will start to work to issue grants for these funds. These funds are just the ones that have been issued by MoDOT, the primary airports in Missouri have received significant funding through these three programs directly.

The last funding program is in the Bipartisan Infrastructure law (BIL). There are three separate new funding programs. The first program is called the Airport Infrastructure Grants, this will have the most significant impact on MoDOT and Missouri's airports. These are formula-based allocations administered to NPIAS for the next five federal fiscal years. These funds can be partnered with airport improvement program funds so there could be the ability to accelerate some projects and maybe increase the scope of some desired projects. Under the state block grant program, airports will receive \$11.1 million in fiscal year 2022; this allocation amount may change each year. The department is waiting for additional guidance on this program and once that is received MoDOT will work with airports to solicit grants for those funds. The other two programs are competitive programs, and each have \$1 billion available for the Airport Terminal Program and the Air Traffic Control Infrastructure Program. For the terminal program at least, 10 percent will be allocated to general aviation so there may be some opportunities there. That program will be 95 percent federally funded. Airports can start to apply for those funds directly to the Federal Aviation Administration (FAA) by the end of the month. Hopefully some local airports will be able to apply and compete for those funds. For the traffic control infrastructure program there are not a lot of details available about it yet.

The Aviation Advisory Committee was formed in 1987 to advise the Missouri Highways and Transportation Commission on aviation matters. The department has a strong working relationship with the Aviation Advisory Committee and the various organizations and interests its members represent. Committee members represent pilot groups, airport management, aviation education, business owners, and aviation consulting firms. The Committee meets at least twice a year to discuss various statewide aviation issues, including legislative initiatives and aviation funding. The committee has been a strong advocate for aviation legislative issues such as the extension of the sunset date for jet fuel sales taxes into the Aviation Trust Fund. Mr. Stockam shared the Aviation Advisory Committee has continuously supported transportation funding proposals in Missouri, including those that would solely benefit roads

and bridges. Mr. Stockam has served as the advisory committee chair since 2009. He indicated that it is time for him to pass the torch to Abe Forney, Airport General Manager of the Rosecrans Municipal Airport, as the next chair. Mr. Stockam noted Missouri has a unique opportunity over the next five years with the additional funds for aviation in Missouri. He pleaded with the commission to make sure MoDOT is staffed at the levels necessary to administer these additional funds.

Commissioner Smith noted how important the airports are in the small communities and expressed his appreciation for MoDOT's Aviation section for the work they do to support those airports. He also thanked Mr. Stockam for his years of service as an aviation leader in Missouri.

#### MISSOURI DRAFT STATE FREIGHT AND RAIL PLAN

On behalf of the Director, Cheryl Ball, Waterways and Freight Administrator, explained the Fixing America's Surface Transportation Act and the Infrastructure Investment and Jobs Act require the Missouri Department of Transportation to develop a statewide freight plan every four years to access portions of federal funds. MoDOT last updated the State Freight Plan in 2017. Each state is encouraged to develop a State Rail Plan (SRP) to present priorities and strategies to enhance rail service that benefits the public. MoDOT completed the last SRP in May of 2012. MoDOT staff initiated a combined State Freight and Rail Plan update (SFRP) in January 2020. Stakeholder and public comments have been received throughout the plan development. Due to COVID-19, all engagement has been through virtual meetings, telephone discussion, or comments submitted through the SFRP website.

The Long-Range Transportation Plan (LRTP) was approved by the Commission in 2018. The LRTP established five goals as the vision for transportation in Missouri: (1) Take care of the transportation system and services we enjoy today, (2) Keep all travelers safe, no matter the mode of transportation, (3) Invest in projects that spur economic growth and create jobs, (4) Give Missourians better transportation choices, and (5) Improve reliability and reduce congestion on Missouri's transportation system. The SFRP

is a deeper dive into the LRTP goal of investing in projects that spur economic growth and create jobs.

This is the first combined State Freight and State Rail Plan for Missouri.

The SFRP provides an update to information contained in the 2017 Freight on the Move and the 2012 SRP, documents the links between transportation investment and economic growth, and provides goals and strategies to help Missouri capitalize on its strengths for efficient freight movement. The SFRP includes seven goals that align with MoDOT's pillars of safety, service, and stability. (1) Improve the safety and security of the multimodal freight and passenger rail system. (2) Improve the connectivity and mobility of the multimodal freight and passenger rail system. (3) Support equity and environmental resiliency of the multimodal freight and passenger rail system. (4) Improve coordination and collaboration with freight and passenger rail and stakeholders and regional planning partners. (5) Maintain the multimodal freight and passenger rail system in good condition. (6) Support economic growth and competitiveness through strategic investments in the multimodal freight and passenger rail network. (7) Institute policies and practices that encourage innovation and efficient use of resources.

Ms. Ball described how freight drives Missouri's economy and what makes up the freight network in Missouri. Using 2018 data, more than 985 million tons of freight moved across Missouri, that equates to 161 tons of freight per Missourian. Freight movement supports 482,000 jobs in Missouri out of the 2.5 million jobs in the state. Missouri's multimodal freight network consists of 8,200 miles of state highway system, all the class 1 railroads and short lines which totals about 5,300 miles of rail, all public ports, and three cargo airports located in Kansas City, St. Louis, and Springfield.

The multimodal freight network provides Missouri businesses with access to supplies and raw materials and access to domestic and global markets it also provides critical connections for our national freight economy and movement of goods from place to place. The network supports Missouri's strongest industry sectors which include transportation, manufacturing, and agriculture.

In 2018 Missouri had over 985 million tons of freight valued at \$1.1 trillion dollars. It is anticipated in 2045 Missouri will have 1.1 billion tons of freight valued over \$1.8 trillion dollars. A large impact to the state of Missouri and a lot of things moving on the transportation system, a 19 percent increase in tonnage and a 57 percent increase in value. Commodity flow is reviewed by all modes. The modes of rail and truck remain predominant and split at about 50/50 every year, this has been consistent since MoDOT started doing freight plans and little change is anticipated in 2045. What was of interest was the tonnage for rail decreases but the value of it increases over time. The flow of commodities through Missouri is anticipated to increase from 583 million tons in 2018 to 700 million tons in 2045. This keeps Missouri as a critical location to keep freight flowing across the nation. The inbound and outbound freight tonnage stays about the same so Missouri is producing and receiving about the same amount of goods so there is no surplus or deficit in capacity.

Missouri has a few key highway corridors for freight. Interstate 44 continues to be the work horse for the state in both tonnage and value of freight. Interestingly, Highway 60 across the southern part of the state carries more freight than other heavy freight corridors including Interstate 70. By 2045 Interstate 44 is expected to continue to be the state's top freight corridor, carrying a projected 3.8 billion tons. I-270 and I-170 in the St. Louis area are projected to become the second- and third-most important corridors in terms of tonnage, each carrying about 575 million tons.

In addition to the federal requirements for the SFRP, this project included analyses for commercial motor vehicle parking and the economic impacts of passenger rail. This plan reviewed both public and private truck parking locations near rural interstates which is where the long-haul trucks trying to find safe places to park as they take their required hours of service breaks. Out of 141 locations there are 87 of which have over 100 percent utilization between the peak hours of 2 and 3 am the other 23 parking areas are between 80 and 100 percent utilization. There is considerable need for more truck parking in Missouri both public and private. The plan looked at the economic impact generated by the Missouri River Runner,

Missouri's state supported passenger train which generates about \$65 million in labor income, \$208 million in economic activity, and generates over \$22 million in taxes annually. Missourians were asked to submit public comments on what they want passenger rail to look like in Missouri. There was strong support for expanding rail to connect large communities of St. Joseph, Springfield, Branson, and Hannibal to the existing Missouri River Runner that goes from Kansas City to St. Louis. They want to provide transportation options that give access to the state capitol, tourist destinations, and educational institutions.

Ms. Ball explained this plan includes strategies to support Missouri's growing economy. The first strategy is to expand the Ag Coast of America. The St. Louis region has coined the term Ag Coast of America. The goal is to provide support to increase shipments of agricultural products on the Mississippi and Missouri Rivers. The plan supports that goal and to increase its boundaries through the state. The next strategy is to support Missouri's thriving and growing manufacturing sector that includes our motor vehicles, e-commerce, warehousing, distribution, and rail spurs into industrial areas. Another strategy will support efficient and intelligent multimodal freight corridors that is leveraging technology solutions and operational changes instead of building capacity in some places, this may include way finding to identify freight generators in rural parts of the country and the use of freight-centric design guidelines. The final strategy is expanding freight and passenger rail market opportunities to make Missouri more competitive for shippers and provide better service and access for passengers.

This plan has been developed in collaboration with planning partners, industry, and MoDOT's districts. Following today's presentation will begin a four-week public comment period on the Draft SFRP. After reviewing comments received, MoDOT staff will bring the final SFRP to the Commission. Commissioner Waters expressed his appreciation for the hard work that went into this plan to apply value to the tonnage of freight that is moving within and through the state and stated this will be a valuable tool for the state into the future.

## MISSOURI CENTER FOR TRANSPORTATION INNOVATION (MCTI) – TWO YEARS LATER

On behalf of the Director, Jen Harper, MoDOT Research Director, Dr. Bill Buttlar, MCTI Director and Dr. John Myers, MCTI Deputy Director reflected on when MoDOT and the University of Missouri System formed the Missouri Center for Transportation Innovation in November 2019. The purpose of the center was to develop collaborative relationships between the campuses in order to conduct research more effectively for MoDOT and to consolidate the power of the four University of Missouri campuses in pursing national transportation research opportunities. The University of Missouri System consists of the following: Missouri University of Science and Technology, University of Missouri-Columbia, University of Missouri-Kansas City, and the University of Missouri-St. Louis.

The Research Center encourages better collaboration between the universities which in turn leads to stronger research teams working on MoDOT research projects. This leads to more efficient and timely research results that can be quickly implemented by the department. This presentation provided an overview of the first two years of the center's operation and successes in the areas of research, outreach, education and workforce, and growth.

Research on "Enhanced Camber Calculations for Prestressed Concrete Bridge Girders" and "Pollinator Habitat Along Highway Right of Way" have recently been published and "Evaluation of Missouri's NBI Data to Predict the Deterioration of Bridge" and "Safety Effectiveness of Temporary Rumble Strips in Work Zones" will be published soon. Dr. Buttlar highlighted the temporary rumble strips research that involved three of the four campuses and was a quick six-month study. Dr. Buttlar also shared about another research project that was accomplished with pooled funds and by working with an out of state university on the assessment and repair of prestressed bridge girders subjected to over height truck impacts. Another research project with national significance is being conducted regarding the use

of waste plastic and ground tire rubber in asphalt. A pilot project is in place in Columbia and another project is being designed for Pemiscot county.

Dr. Buttlar described the outreach efforts through technical advisory groups. These groups will bring collaboration from different areas to address transportation issues. MCTI is looking forward to getting these groups together prior to MoDOT's research day later this fall. In addition, he shared about how this research is being discussed at a future pavement symposium. One research project that was shared has been improved upon by a student who found a way to beat the benchmark twice. Dr. Myers shared how one of the objectives of MCTI was to bring together the expertise on all four campuses and connecting them to seek larger projects. Combining resources also leads to opportunities to compete for larger research projects.

The Research Center's activities help develop future transportation engineers, which is a benefit to MoDOT and the State of Missouri. Approximately 50 faculty are involved with MCTI and 57 students have worked or are working on MCTI projects. Dr. Myers explained having students involved in these research projects, is giving students a technical advantage when they enter the workforce so whether they go to work for MoDOT, a local municipality, or the consulting industry a lot of the courses developed working through the four campuses as well as MCTI gives them a competitive edge. A lot of students end up at MoDOT for example and this will give them a head start in terms of their professional career. An organization under the MCTI umbrella includes Missouri's Local Technical Assistance Program (LTAP). This provides a connection between research and finding local communities where the research may be applied to prove concepts. This is a mutually beneficial relationship. Additionally, MCTI has hosted a webinar series with an international impact. These webinars included speakers from academia, industry, and agencies.

MCTI has been awarded over \$4.5 million in research from MoDOT and almost \$1.5 million from other federal/state agencies, cities, and states. These funds have been applied to 24 projects. The original

target was for three million and that amount ended up doubling to six million and is a great sign of the success of the program. Mr. Myers indicated they look forward to continued growth in the volume and value of research that MCTI can provide not only in Missouri but to the nation. The University of Missouri System has benefited by combining the strengths of the universities for more opportunities in national transportation research.

Commissioner Ecker thanked the group for their presentation and noted that it is exciting to see what can happen in two years when everybody works together and MCTI is going to be a great benefit to MoDOT and the University of Missouri system.

# REPORT AND RECOMMENDATIONS REGARDING THE NORTHWEST DISTRICT BRIDGE BUNDLE PROJECT IN CAROLL, CHARITON, GRUNDY, LINN, LIVINGSTON, MERCER, PUTNAM, AND SULLIVAN COUNTIES, INCLUDING APPROVAL AS A DESIGN-BUILD PROJECT AND DELEGATION OF AUTHORITY

On behalf of the Director, Marty Liles, Northwest District Engineer, recommended the Commission approve the Northwest District Bridge Bundle Project as a Design-Build project and approve authority be delegated to the Deputy Director/Chief Engineer or his designee to approve and execute documents and expend funds on behalf of the Missouri Highways and Transportation Commission for the following items on the Northwest District Bridge Bundle Design-Build Project:

- **Escrow of Bid Documents** Approve authority to execute agreements, affidavits, and related documents and expend funds for costs associated with the escrow of bid documents on the project.
- **Agreements** Approve authority to execute agreements with local governments including other entities for cost-share, enhancements, use of property, environmental mitigations, utilities, etc. on the project, subject to approval as to form by the Chief Counsel's Office (CCO) and the Commission Secretary's (CS) attestation.
- **Railroad Agreements** Approve authority to execute agreements pertaining to railroads, subject to approval as to form by CCO and CS attestation.
- **Construction Change Orders** Approve authority to approve construction change orders on the project.
- Consultant Engineering Services Approve authority to execute contracts for engineering services needed subject to approval as to form by CCO and CS attestation and in keeping with the Brooks Act, 40 USC 1101 et seq. and 23 CFR 172.5 as well as Section 8.285 RSMo.
- Other Approve authority to expend funds for the project, as well as approve, execute, sign and seal project specific documents.
- **Design Exceptions** Approve authority to sign design exceptions specific to the design of the project currently delegated to the State Design Engineer and the State Bridge Engineer, subject to consultation with the department's technical experts.

Project changes resulting from this delegation will not exceed the cap of two percent over the programmed cost or those changes will be taken back to the Commission.

The Northwest District Bridge Bundle Project procurement process will begin May 2022. Funds for this project are included in the draft 2023-2027 Statewide Transportation Improvement Program. The project is estimated at \$29.1 million total for engineering, right of way, utility relocation, and the design-

build contract. Via approval of the consent agenda, the Commission unanimously approved the delegation of authority as recommended and noted above.

## PROPERTY ACQUISITION AND CONVEYANCES

# CONSIDERATION OF EXCESS PROPERTY DISPOSAL, FORMER WILLOW SPRINGS DISTRICT OFFICE COMPLEX, HOWELL COUNTY

In keeping with the Commission's policy regarding disposition of Commission-owned property or property rights, the sale of all properties owned by the Commission with appraised or sale values of \$200,000 or more must be approved by specific Commission action.

On behalf of the Director, Eric Schroeter, Assistant Chief Engineer, and Brenda Harris, Assistant State Design Engineer-Right of Way, recommended the Commission convey the former Willow Springs District Office Complex for \$1.00 ending the lease to own contract, and consider expenses incurred by the City for the operation and maintenance of the aging facility over the contract period.

On June 8, 2011 the Commission approved the Bolder Five-Year Direction, which included the closure of the former District 9 office complex in Willow Springs, Missouri and directed MoDOT to

utilize it for the benefit of the local community. At its November 2, 2011 and December 7, 2011 meetings, the Commission discussed its options for disposal of this property. On February 1, 2012, the Commission entered a ten-year lease of premises with the option to purchase agreement with the City of Willow Springs for the former Willow Springs District Office Complex to encourage economic development, other new employment opportunities, and additional economic activity through student tuition. An economic development goal was established in the agreement. Upon reaching the goal, the Commission agreed to transfer ownership of the property to the City of Willow Springs. The 10-year lease to own term ends March 29, 2022. From 2012 through January 31, 2022, the City of Willow Springs has met a total economic goal of \$1,017,515. The City has also incurred costs for the operation and maintenance of the aging facility structure and equipment in excess of \$400,000. Additionally, the city is partnering with the Willow Springs School District to convert the facility into a higher learning campus, furthering the goal to encourage economic development. A Feasibility Report determined the city would need to invest \$2,000,000 in building repairs and construction to make the facility usable for the future learning campus.

Via approval of the consent agenda, the Commission unanimously approved the property conveyance described above.
