Furnish, Deliver, and Stockpile 2,000 tons of Class 2 (1" – 3/8") Ballast.

3. Add the following to the RFB as Section 2.c.vi:

Ballast material shall be delivered to the site and dumped in a stockpile at a specific location(s) (as determined by PLCPA) on the PLCPA property. All ballast material deliveries shall be witnessed by a representative of PLCPA. A copy of the truck weight ticket for each truck delivery shall be furnished to the PLCPA representative on-site; each ticket must show the gross delivery weight, truck tare weight, and net delivery weight for each load. The ballast material supplier shall also furnish to PLCPA prior to the start of material deliveries the truck scale information for the certified scale being used to weigh each truck load of ballast material delivered to PLCPA. Truck tare weights shall be taken prior to each load and each truck load ticket shall indicate whether the driver was or was not present in the truck at the time of each weighing of the truck.

4. The following questions have been asked by prospective Bidders. The corresponding answers were provided by the Owner and shall be considered part of the RFB, as appropriate.

Question #1: What size kegs would the port like provided, 100 lb. or 50 lb.?

Answer #1: 100-lb. kegs

Question #2: What size rail will the joint bars and anchors be installed on?

Answer #2: The site has both 100-lb. and 112-lb. rail.

Question #3: What diameter and length for the bolts requested (washers and nuts to match)?

Answer #3: Bolts shall be 1-inch diameter and 5.5-inches long.

Question #4: Will the material be subject to any Buy American constraints?

Answer #4: No "Buy American" requirements are included in the RFB. See page 6 of the RFB for additional information.

Question #5: Will the unloading of the material need to be prevailing wage?

Answer #5: Yes. The funding source being used by the PLCPA for this rail materials procurement requires prevailing wage. See Annual Wage Order (AWO) No. 28 for Pike County, Missouri, readily available from the Missouri Department of Labor & Industrial Relations website.
