COMMISSION WORKSHOP - FINANCIAL FORECAST

The Commission held a workshop to learn more about how the department determines the amount of funds available to use in the development of the Statewide Transportation Improvement Program (STIP). Brenda Morris, Chief Financial Officer, reviewed the financial forecast and explained that it is the foundation that is used to develop the department's budget that includes targets for the STIP. The financial forecast is an estimate that covers fiscal years 2023 through 2029. Ms. Morris reminded everyone that the forecast is for road and bridge expenditures and does not include multimodal estimates. She also noted that the forecast indicates the department will be able to match all federal funds. Ms. Morris and Todd Grosvenor, Financial Services Director, reviewed the revenue and disbursement assumptions.

By unanimous consensus of all members present, the meeting of the Commission adjourned. * * * * * * *
