HIGHWAY 86 ROAD & INTERSECTION IMPROVEMENTS

Sealed bids for the HIGHWAY 86 ROAD & INTERSECTION IMPROVEMENTS will be received at: GREAT RIVER ENGINEERING, 2826 S. INGRAM MILL ROAD, SPRINGFIELD, MO 65804, until 2:30 P.M. (Prevailing Local Time) on the 9th day of MAY, 2023, at the office of GREAT RIVER ENGINEERING, 2826 S. INGRAM MILL ROAD, SPRINGFIELD, MO 65804, and at that time will be publicly opened and read. All bids shall be submitted as a HARD COPY.

The proposed work includes:

The reconstruction of Route 86 from the intersection of US 65 Highway west to the proposed Thunder Ridge Nature Arena entrance. Improvements will consist of the following: modify the existing two-lane rural highway with a new 4 lane roadway, turn lane intersection improvements at the Intersection of US 65, roundabout capacity improvements at Ridgedale Road, intersection improvements at Devil's Pool Road, new roundabout at Thunder Ridge Entry/Jones Road, and pavement resurfacing.

All bidders must purchase plans through Great River Engineering, Inc. and be on the planholder list in order to bid the project.

A pre-bid conference will be held at 2:00 P.M. on the 25th day of APRIL, 2023 at the office of GREAT RIVER ENGINEERING, 2826 S. INGRAM MILL ROAD, SPRINGFIELD MO 65804. All bidders are encouraged to attend the pre-bid meeting.

All labor used in the construction of this public improvement shall be paid a wage no less than the prevailing hourly rate of wages of work of a similar character in this locality as established by the Missouri Department of Labor and Industrial Relations (State Wage Rate).

All bidders must be on MoDOT's Qualified Contractor List per Section 102.2 of the Missouri Standard Specifications for Highway Construction, 2022 Edition including all revisions. The contractor questionnaire must be on file 7 days prior to bid opening.

Contractors and sub-contractors who sign a contract to work on public works projects shall provide a 10-Hour OSHA construction safety program, or similar program approved by the Department of Labor and Industrial Relations, to be completed by their on-site employees within sixty (60) days of beginning work on the construction project.

A certified cashier's check or a bid bond in the amount of 5% shall be submitted with each proposal.
