Dear Consultant:

The City of Hazelwood is requesting services of a consulting engineer firm to perform the described professional services for the project included on the attached list. If your firm would like to be considered for these services, you may express your interest by responding to the appropriate office, which is indicated on the attachment. Limit your letter of interest to no more than 5 pages. This letter should include any information which might help us in the selection process, such as the persons or team you would assign to each project, the backgrounds of those individuals, and other projects your company has recently completed or are now active. It is required that your firm's Statement of Qualification (RSMo 8.285 through 8.291) be submitted with your firm's Letter of Interest, or be on file with the City of Hazelwood. The statement of qualification is not included in the total page count limit.

DBE firms must be listed in the MRCC DBE Directory located on MoDOT's website at www.modot.gov, in order to be counted as participation towards an established DBE Goal. We encourage DBE firms to submit letters of interest as prime consultants for any project they feel can be managed by their firm.

It is required that your firm be prequalified with MoDOT and listed in MoDOT's Approved Consultant Prequalification List, or your firm will be considered nonresponsive.

We request all letters be received by 12:00 p.m., July 26, 2023, at the City of Hazelwood, Department of Public Works, 415 Elm Grove Lane, Hazelwood, MO 63042.

Location:	Teson Road, Hazelwood, MO 63042
Proposed Improvement:	The resurfacing of Teson Road between Howdershell Road and Aubuchon Road will include widening the road to a minimum of 24 feet wide with two-foot shoulders, milling as needed and repaving the entire road, install new sidewalk and ADA compliant crosswalks, and implement safety improvements.
Length:	2.2 miles
Approximate Construction Cost:	\$3,274,620
DBE Goal Determination:	16%
Consultant Services Required:	<u>Right-of-Way</u> Right-of-way phase services may include but are not limited to acquisition of temporary and/or permanent realty rights including land, easements, and access rights necessary to construct, operate, and maintain the project. The consultant may need to perform property valuations/appraisals, negotiation activities, and relocation services as necessary to acquire real property to clear the project for construction. <u>Roadway</u> The engineering responsibilities may include but are not limited to the following: the preparation of Preliminary and Contract plans and Right of Way Plans. Design services may include right of way plans, surveying, geotechnical investigations, public involvement, environmental and historic preservation services/permits, contract documents, assisting with the bidding process, construction support/construction inspection, utility coordination/permits and traffic controls including the preparation of PS&E and final documents. <u>Sidewalks</u> The engineering responsibilities may include but are not limited to: The preparation of Conceptual plans, Preliminary plans, Contract plans, Right of Way plans, preparing and submitting necessary permits, contract documents, assisting with the bidding process for ADA compliant sidewalks and preparation of PS&E <u>Construction Inspection</u> Construction Phase: work with contractor on behalf of the City, assist with preconstruction conference, perform periodic site inspection, prepare change orders, inspect construction materials, check shop drawings submitted by contractor, conduct

	construction test and inspection, be present during critical construction operations, work with the City to do full time inspections and reporting and participate in final inspection.
