Proposed Improvement:	Total roadway reconstruction. Removal of existing asphalt and underlying concrete. New asphaltic pavement section will meet City Code for local access street. Removal and replacement of all sidewalks and curb/gutter to meet ADA requirements. Storm sewer improvements. All intersections shall incorporate concrete pavers and be consistent with the Downtown Historic District aesthetics. Construction phasing plans.
