100.10.3 WORKING RESTRICTIONS

- A. On each of the project sites, the Contractor shall confine his operations and restrict the storage of equipment and materials to the easement areas shown on the plans. The Contractor will not be permitted to operate equipment or store material on roadways or drives that are normally in use by the public.
- B. The Contractor shall use every precaution to prevent damage to private and public utility lines, conduits, and other improvements. The Contractor will be responsible for all damage to any utility or other such improvement due to his operations, and shall repair or replace as necessary any such damaged facility or make payment to the owner for repair or replacement. Trees and shrubs in the easement areas not specifically marked To Be Removed (TBR) shall be carefully preserved.
- C. The Contractor shall be aware of the following upcoming or in-progress projects in the vicinity. Please note that start / end dates shown are current as of [May 2023](#) and are subject to change:

Canton Avenue Resurfacing (Sponsored by City of University City) Federal Project STP-5402(618); Hanley Road to North and South Road; anticipated start / end of construction: [Completion expected September 2023](#).

Midland Blvd Resurfacing (Sponsored by St. Louis County), Federal Project STP-5523(624), Canton Avenue to Page Avenue (MO Rte D); anticipated start / end of construction [March 2024 – December 2024](#).

The County does not anticipate any delays due to the above projects however the Contractor will be required to coordinate to avoid duplication of work and/ or delays.

- D. No direct payment will be made for compliance with this provision.

100.10.4 ADDENDUMS

It is the responsibility of the bidder to ensure his prospective subcontractors are aware of any addendums issued to the Plans or Construction Contract and Specifications for this project.

100.10.5 CONSTRUCTION DOCUMENTS PROVIDED TO CONTRACTOR

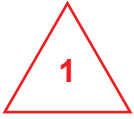
Missouri American Water (water) – existing underground mains (no conflicts anticipated). Several house service valves may require minor grade adjustments.

Spire Missouri East (natural gas) – existing underground mains (no conflicts anticipated). Some house service valves may require minor grade adjustments.

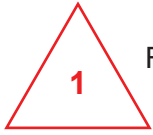
Metropolitan Sewer District (sewer/ drainage) – existing manholes and storm water inlets, underground mains (no conflicts anticipated). Some manhole and inlet tops may require minor grade adjustments.



- C. The contractor agrees that any effects of the presence of the utilities, their relocation, contractor's coordination of work with the utilities and any delay in utility relocation shall not be compensable as a suspension of work, extra work, a change in the work, as a differing site condition or otherwise including, but without limitation, delay, impact, incidental or consequential damages. The contractor's SOLE REMEDY for the effects of the presence of utilities, delay in their relocation or any other effects shall be an excusable delay as provided in Section 105.7.3. The contractor waives, for itself, its subcontractors and suppliers the compensability of the presence of utilities, delay in their relocation, and any cost to the contractor, its subcontractors, and suppliers in any claim or action arising out of or in relation to the work under the contract.
1. The contractor's Work Schedule, required by Section 107.5.1 of the St. Louis County Standard Specifications for Road and Bridge Construction, shall reflect coordination of the contractor's work with that of utility relocation including, without limitation, all dependencies of the contractor's or its subcontractor's work upon relocation of utility lines and facilities and the effects of the utility relocations on the required order of work provided in other parts of the contract documents.
 2. The contractors shall be solely responsible and liable for incidental and consequential damages, to any utility facilities or interruption of the service caused by it or its subcontractor's operations. The contractor shall hold and save harmless St. Louis County from all damages to any utility facilities or interruption of service by it or its subcontractors' operations.
 3. No direct payment will be made for the contractor's compliance with above special provision.
 4. The requirements of this Special Provision are in addition to or supplement to Sections 105.7 through 105.7.6 of the Specifications and are not a replacement of them except, unless and only to the extent there is direct conflict between these provisions and those of the Specifications.
- D. It is the responsibility of the Contractor and sub-contractors performing work to contact the Missouri One Call System, Inc. at 1-800-344-7483 (and also St. Louis County Operations Division about signal and/or lighting conduit at 314-615-0215) at least two (2) full working days, but not more than ten (10) working days, before commencing the excavation activity, as per Missouri State Law. The Contractor requesting the locations shall provide all utilities with the project number and area. He shall also specify on which streets construction will

F. Site inspection of the grading operations at waste and borrow sites will be conducted by St. Louis County Department of Transportation and Public Works. Questions concerning inspection, fees and conditions should be directed to the Code Enforcement Division at 314-615-5184.

G. Environmental and cultural clearances for land disturbance areas include, but are not limited to the following items. The Contractor shall provide County with all applicable permits and clearances for approval prior to commencement of land disturbance activities:

a. Endangered Species Act: Compliance required for the protection of endangered species.

b. Farmland Protection Policy Act: Compliance with the Farmland Protection Policy Act, which has the purpose of minimizing Federal programs' contribution to the unnecessary and irreversible conversion of farmland caused by nonagricultural uses, is required.

i. Permitting Authority: Natural Resources Conservation Service (NRCS)

ii. An aerial map showing the borrow site and Form AD-1006 need to be submitted to the Natural Resources Conservation Service (NRCS) serving the area. Form AD-1006 may be obtained from the NRCS office. Parts I and III of Form AD-1006 should be completed by the Contractor. The form should be sent to the NRCS for completion of Parts II, IV, and V. The NRCS office should be instructed to return the form to:
