The selection of the consulting firm resulting from this RFQ is subject to a post-award negotiated contract. If the parties are unable to agree to terms in the post-award contract, the Town shall reserve the right to cancel the selection of that consulting firm and the right to select a different firm.

It is required that your firm be prequalified with MoDOT and listed in MoDOT's Approved Consultant Prequalification List, or your firm will be considered non-responsive.

Purpose: To determine where/if a suitable platform/station for Amtrak passenger rail service can be located in or near the Town of Carrollton, MO on the BNSF rail line. The area of consideration is from the vicinity of the BNSF maintenance facility (old depot) just west of S. Main St. to a point approximately two (2) miles northeast, prior to the first northeast curve of the rails.

Required Services: The scope of service in Phase I may include but is not limited to: feasibility study of potential sites, analysis of flood potential and other significant environmental considerations, coordination with Amtrak and BNSF, and preliminary engineering design including evaluation criteria of estimated time, level of effort, and cost for comparison of each site. If one or more suitable sites can be identified, a site evaluation, if necessary, will be conducted by the Town of Carrolton. Upon selection of a site location, subsequent phases may include but are not limited to surveys, easement/ROW determination, environmental services and permits, land acquisition, platform/station design, access and parking, utilities and lighting, construction contract preparation, bid advertising, letting and award services, and construction administration and observation services.

Information provided to the Town of Carrollton must include at a minimum:

- 1. The specialized experience and technical competence of the firm with respect to conceptual planning, site structure evaluation, and infrastructure related work
