Bids received after the deadline date and time will be returned unopened. The project will be awarded to the lowest, responsive, responsible bidder after the bid opening.

## The proposed work includes:

Replacing concrete curb & gutter, sidewalk, and driveways, resurfacing, some minor storm sewer work, striping and landscape restoration.

All labor used in the construction of this public improvement shall be paid a wage no less than the prevailing hourly rate of wages of work of a similar character in this locality as established by the Department of Labor and Industrial Relations (Federal Wage Rate), or state wage rate, whichever is higher.

The City of Belton hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award.

All bidders must be on MoDOT's Qualified Contractor List per Section 102.2 of the Missouri Standard Specifications for Highway Construction, 2023, including all revisions. The contractor questionnaire must be on file 7 days prior to bid opening. No Bidder may withdraw their bid within 60 days after the actual date of the bid opening.

The DBE (Disadvantaged Business Enterprise) contract goal for the amount of work to be awarded for the North Scott Avenue Improvements project is 4% of the total federal project price. The bidder shall also complete the DBE Identification Submittal forms for the project in accordance with the General Provisions. Missouri Law, 292.675 RSMO, requires any awarded contractor and its subcontractor(s) to provide a ten-hour Occupational Safety and Health Administration (OSHA) Construction Safety Program for their on-site employees.
