This letter should include any information which might help us in the selection process, such as persons or team you would assign to each project, the background of those individuals, and other projects your company has recently completed or are now active. It is required that your firm's Statement of Qualification (RSMo 8.285 through 8.291) and an Affidavit of Compliance with the federal work authorization program along with a copy of your firm's E-Verify Memorandum of Understanding (15 CSR 60-15.020) be submitted with you firm's Letter of Interest.

DBE firms must be listed in the MRCC DBE Directory located on MoDot's website at www.modot.gov, in order to be counted as participation towards an established DBE Goal. We encourage DBE firms to submit letters of interest as prime consultants for any project they feel can be managed by their firm.

It is required that your firm be prequalified with MoDOT and listed in MoDOT's Approved Consultant Prequalification List, or your firm will be considered non-responsive.

We request all letters to be received by 5pm, November 15th, 2023 at 8940 Lyra Drive, Suite 200, Columbus OH 43240.
