It is required that your firm be prequalified with MoDOT and listed in MoDOT's Approved Consultant Pregualification List, or your firm will be considered nonresponsive. We request all Submissions be received by 2 pm, December 5th, 2023 (12/5/2023) at the JCPA offices at 114 Mississippi Ave, Crystal City, MO 63019.
