It is required that your firm's Statement of Qualification (RSMo 8.285 through 8.291) be submitted with your firm's Letter of Interest, or be on file with State Technical College of Missouri. The statement of qualification is not included in the total page count limit.

DBE firms must be listed in the MRCC DBE Directory located on MoDOT's website at www.modot.gov, in order to be counted as participation towards an established DBE Goal. We encourage DBE firms to submit letters of interest as prime consultants for any project they feel can be managed by their firm.

It is required that your firm be prequalified with MoDOT and listed in <u>MoDOT's Approved Consultant Prequalification</u> <u>List</u>, or your firm will be considered non-responsive.

We request all letters be received by 12:00 p.m., Wednesday, December 27, 2023, at Attn: Brad Crede, 1 Technology Dr. Linn, MO 65051, or delivered in person to Nilges Technology Center, Room 106.
