MAJOR REVISIONS:

606.61 MGS 38-Inch Two-Tube Rail Transitions

(sheets 1 through 3 of 3) New standard plan for guardrail transitions to bridge railing.

616.20B Temporary Traffic Control Plans

(sheets 2 and 3 of 5) Removed flag assembly from flagger sign.

(sheet 5 of 5) Added "required" to truck mounted attenuator for striping warning trucks.

D-2BS Replaced item number 6123000A with 6123001 Truck Mounted Attenuator (TMA). Removed "with flags" from descriptions of signs WO8-6 Truck Crossing and WO20-7 Flagger.

MINOR REVISIONS:

203.20G Superelevation, Spirals and Widening (Undivided Highway)

(sheet 1 of 4) Fixed spelling typo.

203.21K Superelevation, Spirals and Widening (Divided Highway)

(sheets 1 and 2 of 3) Fixed spelling typo.

203.22A Superelevation, Spirals and Widening

(*sheet 1 of 2*) Capped the superelevation runoff lengths for 50 mph and higher to match 7^{th} ed. "*Green Book*" correction.

607.10W Chain-Link Fence

(sheet 1 of 1) Added "nominal inside diameter" to first general note.

607.11J Chain-Link Fence for Retaining Walls

(sheet 1 of 1) Added "Pipe post sizes are nominal inside diameters." to general notes.

607.20H Woven Wire Fence

(*sheets 1 and 2 of 2*) Specified nominal inside diameter for gate post size and typographical errata.

608.00L Paved Approaches

(*sheet 1 of 2*) Added 4" Type 1 or 5 Base to Section E-E, restored Detail A (curb height transition), and in the general notes changed the word "dip" to gutter line.

(*sheet 2 of 2*) Added 4" Type 1 or 5 Base to Section K-K, changed the subtitle from "Not Adjoining Curb and Gutter Sections" to "Adjoining Curb Without Gutter Sections" and restored dashed lines for mainline curb.

612.20F Sand Filled Impact Attenuators

(*sheet 1 of 1*) Removed archaic "MoDOT type" sheeting verbiage and changed general note to "Object markers shall be placed on lead module facing traffic."

616.10BD Temporary Traffic Control Devices

(*sheet 6 and 7 of 9*) Removed "with flags" from descriptions of signs WO8-6 Truck Crossing and WO20-7 Flagger.

805.00A Seeding

(*sheet 1 of 1*) Added to notes "Fertilizer = pounds of N/acre, pounds of P/acre, pounds of K/acre" and specified in tables.

902.30P Traffic Signals – Post Bases

(sheet 1 of 2) Clarified rock embedment table by removing base types.
