The owner reserves the right to reject any and all bids and to waive any irregularities in the best intersect of the City with MoDOT's consent. Contractor should be aware that these are being bid as separate projects and bid forms for both projects must be submitted at the time of bid.

Subcontractors utilized for DBE Goals must appear on the MoDOT/Kansas City Approved DBE List and on the MoDOT DBE Directory located at http://www.modot.mo.gov/business/contractor_resources/bid_opening_info/bidGenInfo.shtml.

Each bidder must certify that it is not presently debarred, suspended, proposed for debarment, declared ineligible or voluntarily excluded from covered transactions by any federal agency and they have not been convicted or had civil judgment rendered within the past 3 years.
