This Request for Bid (RFB) is to solicit reasonable offers for best value comparison of LABOR ONLY to:

- Perform marine vessel repowering installation entailing the vessel prep for hot work, dry-dock, and crane work necessary for the replacement of three (3) existing propulsion engines with three (3) new U.S. Environmental Protection Agency-certified Tier III 475 HP propulsion engines and generators on towboat work class marine vessel
- As well as replacing two (2) existing propulsion engines with two (2) new U.S. Environmental Protection Agency-certified Tier III 1500 HP engines and generators on another towboat work class marine vessel
- And including the labor to install corresponding generators, coolers, exhaust, gears, indicators, and controls for BOTH vessels as required for sea trial certification with a contract period of 120 days from agreed date for Notice to Proceed on each vessel.
- The existing engines must be rendered inoperable and scrapped
