REQUEST FOR QUALIFICATIONS CONSTRUCTION ENGINEERING SERVICES

Platte County Public Works is requesting the services of a consulting engineering firm to perform the Construction Engineering Services for a bridge replacement project. If your firm would like to be considered for the Construction Engineering Services, you may express your interest by submitting a Letter of Interest to Platte County Public Works, address below. Limit your letter of interest to no more than 5 pages. This letter should include any information which might help us in the selection process, such as the persons or team you would assign to the project, the backgrounds of those individuals, and other projects your company has recently completed or are now active. It is required that your firm's Statement of Qualification (RSMo 8.285 through 8.291) be submitted with your firm's Letter of Interest, or be on file with Platte County Public Works. The Statement of Qualification is not included in the total page count limit.

DBE firms must be listed in the MRCC DBE Directory located on MoDOT's website at www.modot.gov, in order to be counted as participation towards an established DBE Goal. We encourage DBE firms to submit letters of interest as prime consultants for any project they feel can be managed by their firm.

It is required that your firm be prequalified with MoDOT and listed in MoDOT's Approved Consultant Prequalification List, or your firm will be considered non-responsive.

We request all letters be received by 4:00 pm, (07/26/2024) at **15955 Hwy 273, Platte City, MO 64079**.
