Contractors and sub-contractors who sign a contract to work on public works project provide a 10-Hour OSHA construction safety program, or similar program approved by the Department of Labor and Industrial Relations, to be completed by their on-site employees within thrity (30) calendar days of beginning work on the construction project. No matter what date the contractor chooses to begin the project, the project must be completed on or before November 15, 2024.

A certified or cashier's check or a bid bond in the amount of 5% shall be submitted with each proposal.
