

ADDENDUM NO. 1

- 1. Bidders shall submit bids on the attached revised Quotation Form, which must include acknowledgement of Addendum #1.
- 2. The contract DBE goal for this project is 3% of the total contract.
- 3. Clearing and Grubbing pricing should include rough grading.
- 4. Rectangular Rapid Flashing Beacons are supply only. Installation will be by others.
- 5. Bid Form Item 12 Asphalt Patching Revised quantity is for 24 inches in front of the gutter.
- 6. Bid Form Items 13-15 1" Asphalt Mill and Overlay Contractor to complete a 1 inch deep, 6 foot wide mill and overlay in front of gutter.
- 7. Delete the following notes where they occur on all sheets of the plans:
 - a. Delete "Seeding and mulching of all disturbed areas shall be by others." Contractor responsible for this scope of work.
 - b. Delete "All tree removal shall be by others. All clearing, grubbing and disposal of tress, brush, and debris shall be by others." Contractor responsible for this scope of work.
 - c. Delete "Restoration of existing gravel drives and driveways to preconstruction condition and grade shall be by others." Contractor responsible for this scope of work.
 - d. Within note: "Unit price for installation of curb, driveway aprons and sidewalk shall include all concrete, labor, forms and equipment necessary for the complete installation of the item. Rock shall be furnished by the City of Rolla." Delete "Rock shall be furnished by the City of Rolla." Contractor responsible for this scope of work.
 - e. Delete "Erosion control shall be by City." Contractor responsible for this scope of work.
 - f. Delete "Sawcut asphalt at match lines by others." Contractor responsible for this scope of work.
 - g. Delete "Remove and discard existing drain pipe by others." Contractor responsible for this scope of work.
 - h. Delete "Remove and relocate existing mailboxes by others." Contractor responsible for this scope of work, and for ensuring postal service remains uninterrupted.
- 8. Bid date remains the same.
