The City of Lee's Summit, Missouri is requesting Bids for the construction of City Project # $575 - 3^{rd}$ Street Improvements Jefferson St to Blue Parkway. Bids will be received electronically submitted via QuestCDN (<u>www.QuestCDN.com</u>) until 2:00 PM local time on October 30, 2024 and at that time will be publicly opened and read via Zoom teleconferencing (see Bid Docs. on QuestCDN for Zoom access).

The proposed work includes: The installation of storm pipe, curb inlets, water main replacement, sidewalk, shared-use path, road paving, curb and gutter, pavement marking and street lighting. The project also includes additional streetscape elements like trees, tree grates and pedestrian lighting to be added along 3rd Street with the Downtown Central Business District between Jefferson Street and Market St.

A Pre-Bid conference for the Project will be held on **October 9**, at **2:00 P.M local time** at Lee's Summit City Hall, 220 SE Green Street, Lee's Summit, MO in the Strother Conference room. Attendance at the prebid conference is encouraged but not required.

All labor used in the construction of this public improvement shall be paid a wage no less than the prevailing hourly rate of wages of work of a similar character in this locality as established by the Department of Labor and Industrial Relations (Federal Wage Rate), or state wage rate, whichever is higher.

The City of Lee's Summit, Missouri hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award."

All bidders must be on MoDOT's Qualified Contractor List per Section 102.2 from the current version of the Missouri Standard Specifications for Highway Construction, including all revisions. The contractor questionnaire must be on file 7 days prior to bid opening.

Contractors and sub-contractors who sign a contract to work on public works project provide a 10-Hour OSHA construction safety program, or similar program approved by the Department of Labor and Industrial Relations, to be completed by their on-site employees within sixty (60) days of beginning work on the construction project.

A certified or cashier's check or a bid bond in the amount of 5% shall be submitted with each proposal.

The City of Lee's Summit, Missouri reserves the right to reject any or all bids.

The DBE Goal for this project is 12% and On-the-job trainee hours will be 0 hours.

No 2nd tier subcontracting will be allowed on this project.
