## 3. **QUESTIONS**

**Question:** After reviewing the specs regarding the concrete placement, I wanted to confirm the option to use fix form concrete placement is an acceptable method. We plan to set fix forms with the use of a vibra strike and hand finish since this is a small qty job. Wanted to just make sure a slip form paving machine is not 100% required.

**Answer:** In accordance with Section 501-4.2b.(2) Fixed-form of the P-501 specification, concrete pavement can be placed with equipment specifically designed for placement and finishing using stationary side forms since the project requires less than 10,000 cubic yards of concrete pavement. However, the methods and equipment to be used shall be reviewed and accepted by the RPR prior to concrete placement. Hand screeding and float finishing may only be used on small irregular areas as allowed by the RPR. All methods and equipment to be used for concrete placement shall meet the requirements set forth in the P-501 specification. This includes, but is not limited to, vibrators, concrete placement, consolidation, finishing, and curing.
