Bidder must be experienced in earthmoving and grading construction and other work as described in the Contract Documents.

Bidder must be pre-qualified by MoDOT in accordance with Sec 102.2 of the Missouri Standard Specifications for Highway Construction.

Contractor must affirm that all on-site employees have completed a ten-hour OSHA construction safety program as required under Missouri law (RSMo 292.675).

This project will be partially funded with funding from the Missouri Department of Transportation (MoDOT) and therefore is subject to the regulations associated with that program.

Prevailing wages will be required.
