ADD - "Rip Rap shall be 18-inches in thickness."

ITEM C-102 Temporary Air and Water Pollution, Soil Erosion, and Siltation Control, Section 102-4.1 (c.), METHOD OF MEASUREMENT.

ADD - "Rip Rap shall be 18-inches in thickness."

ITEM P-208 AGGREGATE BASE COURSE, Section 208-2.1, MATERIALS, Aggregate base.

ADD – "Item P-208-5.2, 6" Aggregate for Haul Route shall be used for the proposed haul route and Storage and Staging Area as shown on the plans. The material used shall be at the contractor's discretion and be able to withstand hauling and storage operations throughout the project. No additional payments will be made for fixing or repairing areas that have been damaged throughout the project because of contractor operations. All aggregate associated with this pay item shall be removed at the end of the project."

ITEM P-208 AGGREGATE BASE COURSE, Section 208-2.2, MATERIALS, Gradation requirements.

ADD – "There are no gradation requirements for Item P-208-5.2, 6" Aggregate for Haul Route. The material used shall be at the contractor's discretion and be able to withstand hauling and storage

operations throughout the project. No additional payments will be made for fixing or repairing areas that have been damaged throughout the project because of contractor operations."

ITEM P-208 AGGREGATE BASE COURSE, Section 208-2.3, MATERIALS, Sampling and testing.

ADD – "There are no sampling and testing requirements for Item P-208-5.2, 6" Aggregate for Haul Route. The material used shall be at the contractor's discretion and be able to withstand hauling and storage operations throughout the project. No additional payments will be made for fixing or repairing areas that have been damaged throughout the project because of contractor operations."

ITEM P-208 AGGREGATE BASE COURSE, Section 208-2.2, CONSTRUCTION METHODS.

ADD – "Item P-208-5.2, 6" Aggregate for Haul Route shall be used for the proposed haul route and Storage and Staging Area as shown on the plans. The material used shall be at the contractor's discretion and be able to withstand hauling and storage operations throughout the project. No additional payments will be made for fixing or repairing areas that have been damaged throughout the project because of contractor operations. All aggregate associated with this pay item shall be removed at the end of the project."

ITEM P-208 AGGREGATE BASE COURSE, Section 208-5.1, BASIS OF PAYMENT.

ADD – "Payment for Item P-208-5.2, 6" Aggregate for Haul Route shall also include removal of all aggregate at the end of the project."

ITEM P-605 JOINT SEALANTS FOR PAVEMENTS, Section 605-3.2, Equipment, f. Vacuum Sweeper.

ADD – "In lieu of vacuum sweeping, the joint material may be swept by hand and washed off pavement. Material shall be diluted in turf off pavement to the satisfaction of the engineer. All pavement surface and joints shall be cleaned to the satisfaction of the engineer and specifications P-501 and P-605."

ITEM P-605 JOINT SEALANTS FOR PAVEMENTS, Section 605-3.2, Equipment

ADD – "g. Waterblasting equipment. In lieu of sandblasting, the contractor may elect to use waterblasting equipment. The Contractor must demonstrate waterblasting equipment including the pumps, hose, guide and nozzle size, under job conditions, before approval in accordance with paragraph 605-3.3. The Contractor shall demonstrate, in the presence of the RPR, that the method cleans the joint and does not damage the joint."

DELETE "Cleaning shall be accomplished by sandblasting as specified in paragraph 605-3.2."

CLARIFICATION:

- Q1: Item P-605 requires sandblasting the joints prior to joint sealing. Can pressuring washing
 and cleaning with an air compressor be substituted for the sandblasting?

 No, we will require sandblasting of the joints prior to joint sealing per Item P-605 in the Project
 Manual.
- 2. Can silicone sealant be substituted for the hot applied sealant? The joint sealant will be hot applied per the P-605 specification.
- 3. Can Type 5 base rock be used for the haul route in lieu of the P-208 rock?

 Changes to the pay item for P-208-5.2 6" Aggregate for Haul Route (and Access Road), have been revised as part of this addendum.
- 4. Are Liquidated damages are \$1500 or \$750? In the bid doc area it referenced \$1500, in the contract it references \$750.
 - All liquidated damages will be \$1,500 per day. Page 306 has been revised as part of this addendum.
- 5. Storage and staging area limits and proposed haul route limits can be reduced by contractor if the full area shown on plans isn't deemed necessary. Any modifications outside of the existing limits (beyond the limits shown on plans) must be pre-approved by the engineer before construction.
- 6. P-208-5.2 is to be used to build staging area and proposed access road only. Existing gravel haul routes (Warco Road and gravel roads in farm areas) are to be repaired or improved at the contractor's expense. (It was mistakenly stated in the prebid meeting that P-208-5.2 could be measured for payment for repairs to the existing gravel roads).
- 7. A water source (well water with pump) is located next to the terminal building.

ACKNOWLEDGEMENTS BY BIDDER

- a. By submittal of a proposal, the BIDDER acknowledges and accepts that the quantities established by the OWNER are an approximate estimate of the quantities required to fully complete the Project and that the estimated quantities are principally intended to serve as a basis for evaluation of bids. The BIDDER further acknowledges and accepts that payment under this contract will be made only for actual quantities and that quantities will vary in accordance with the General Provisions subsection entitled "Alteration of Work and Ouantities".
- **b.** The BIDDER acknowledges and accepts that the Bid Documents are comprised of the documents identified within the General Provisions. The BIDDER further acknowledges that each the individual documents that comprise the Bid Documents are complementary to one another and together establishes the complete terms, conditions and obligations of the successful BIDDER.
- **c.** As evidence of good faith in submitting this proposal, the undersigned encloses a bid guaranty in the form of a certified check, cashier's check or bid bond in the amount of 5% of the bid price. The BIDDER acknowledges and accepts that refusal or failure to accept award and execute a contract within the terms and conditions established herein will result in forfeiture of the bid guaranty to the owner as a liquidated damage.
- d. The BIDDER acknowledges and accepts the OWNER'S right to reject any or all bids.
- e. The BIDDER acknowledges and accepts the OWNER'S right to hold all Proposals for purposes of review and evaluation and not issue a notice of award for a period not to exceed **One Hundred and Twenty** (120) calendar days from the stated date for receipt of bids.
- f. The undersigned agrees that upon written notice of award of contract, he or she will execute the contract within thirty (30) days of the notice of award, and furthermore, and provide executed payment and performance bonds within fifteen (15) days from the date of contract execution. The undersigned accepts that failure to execute the contract and provide the required bonds within the stated timeframe shall result in forfeiture of the bid guaranty to the owner as a liquidated damage.
- g. Time of Performance: By submittal of this proposal, the undersigned acknowledges and agrees to commence work within ten (10) calendar days of the date specified in the written "Notice to Proceed" as issued by the OWNER. The undersigned further agrees to complete the Project within **Sixty Fout** (64) Calendar days from the commencement date specified in the Notice to Proceed for the Base Bid and an additional **Fifteen** (15) Calendar Days will be granted if Additive Alternate #1 is awarded.
- **h.** The undersigned acknowledges and accepts that for each and every Calendar day the project remains incomplete and each phase is incomplete beyond the contract time of performance, the Contractor shall pay the non-penal amount of \$1,500 per Calendar day as a liquidated damage to the OWNER.
- i. The undersigned prime contractor, if not a MoDOT certified DBE, hereby assures that they will subcontract Nine percent (9%) of the dollar value of the prime contract to DBE firms or make good faith efforts to meet the DBE contract goal. In addition, the prime contractor will include the DBE clauses (see Supplementary

Provision No. 6 of the Federal and State Provisions) required by the DBE Program adopted by MoDOT and the Sponsor in all contracts and subcontracts relating to this project. The undersigned will complete the DBE Participation information included herein when a DBE goal has been established, including a demonstration of good faith efforts if the DBE goal is not met. If the undersigned prime contractor is a MoDOT certified DBE firm, then the prime contractor must perform at least thirty percent (30%) of the total contract value work with its own forces, and will receive DBE credit for all work which the prime contractor and any other MoDOT certified DBE firm performs directly.

- j. The BIDDER, by submission of a proposal, acknowledges that award of this contract is subject to the provisions of the Davis-Bacon Act and the Missouri Prevailing Wage Law. The BIDDER accepts the requirement to pay prevailing wages for each classification and type of worker as established in the attached wage rate determinations as issued by the United States Department of Labor and the Missouri Division of Labor Standards. The BIDDER further acknowledges and accepts their requirement to incorporate the provision to pay the established prevailing wages in every subcontract agreement entered into by the Bidder under this project. The highest rate between the two (Federal and State) for each job classification shall be considered the prevailing wage.

b. Trade Restriction Certification (49 U.S.C. § 50104, 49 CFR Part 30)

The submission of an offer, the Offeror certifies that with respect to this solicitation and any resultant contract, the Offeror:

Unless the restrictions of this clause are waived by the Secretary of Transportation in accordance with 49 CFR 30.17, no contract shall be awarded to an Offeror or subcontractor:

The CONTRACTOR and OWNER understand and agree that time is of the essence for completion of the Work and that the OWNER will suffer additional expense and financial loss if said Work is not completed within the authorized Contract Time. Furthermore, the CONTRACTOR and OWNER recognize and understand the difficulty, delay, and expense in establishing the exact amount of actual financial loss and additional expense. Accordingly, in place of requiring such proof, the CONTRACTOR expressly agrees to pay the OWNER as liquidated damages the non-penal sum of **One Thousand Five Hundred Dollars (\$1,500.00)** per day for each calendar day required in excess of the authorized Contract Time.

Furthermore, the CONTRACTOR understands and agrees that;

- **a.** the OWNER has the right to deduct from any moneys due the CONTRACTOR, the amount of said liquidated damages;
- **b.** the OWNER has the right to recover the amount of said liquidated damages from the CONTRACTOR, SURETY or both.

Article 7 – CONTRACTOR'S Representations

The CONTRACTOR understands and agrees that all representations made by the CONTRACTOR within the Proposal Form shall apply under this Agreement as if fully rewritten herein.

Article 8 – CONTRACTOR'S Certifications

The CONTRACTOR understands and agrees that all certifications made by the CONTRACTOR within the Proposal shall apply under this Agreement as if fully rewritten herein. The CONTRACTOR further certifies the following;

a. Certification of Eligibility (29 CFR Part 5.5)

- i. By Entering into this contract, the CONTRACTOR certifies that neither he or she nor any person or firm who has an interest in the CONTRACTOR'S firm is a person or firm ineligible to be awarded Government contracts by virtue of Section 3(a) of the Davis-Bacon Act or 29 CFR 5.12(a)(1);
- ii. No part of this contract shall be subcontracted to any person or firm ineligible for award of a Government contract by virtue of Section 3(a) of the Davis-Bacon Act or 29 CFR 5.12(a)(1);
- iii. The penalty for making false statements is prescribed in the U.S. Criminal Code 18 U.S.C.

b. <u>Certification of Non-Segregated Facilities</u> (41 CFR Part 60-1.8)

- **d.** OWNER and CONTRACTOR each bind itself, their partners, successors, assigns and legal representatives to the other party in respect to all covenants, agreements, and obligations contained in the Contract Documents.

Article 10 – OWNER'S Representative

The OWNER'S Representative, herein referred to as ENGINEER, is defined as follows:





Note: Executive Order (EO) 13706, Establishing Paid Sick Leave for Federal Contractors applies to all contracts subject to the Davis-Bacon Act for which the contract is awarded (and any solicitation was issued) on or after January 1, 2017. If this contract is covered by the EO, the contractor must provide employees with 1 hour of paid sick leave for every 30 hours they work, up to 56 hours of paid sick leave each year. Employees must be permitted to use paid sick leave for their own illness, injury or other health-related needs, including preventive care; to assist a family member (or person who is like family to the employee) who is ill, injured, or has other health-related needs, including preventive care; or for reasons resulting from, or to assist a family member (or person who is like family to the employee) who is a victim of, domestic violence, sexual assault, or stalking. Unlisted classifications needed for work not included within the scope of the classifications listed may be added after award only as provided in the labor standards contract clauses (29CFR 5.5 (a) (1) (iii)).

The body of each wage determination lists the classifications and wage rates that have been found to be prevailing for the type(s) of construction and geographic area covered by the wage determination. The classifications are listed in alphabetical order under rate identifiers indicating whether the particular rate is a union rate (current union negotiated rate), a survey rate, a weighted union average rate, a state adopted rate, or a supplemental classification rate.

Union Rate Identifiers

A four-letter identifier beginning with characters other than ""SU"", ""UAVG"", ?SA?, or ?SC? denotes that a union rate was prevailing for that classification in the survey. Example: PLUM0198-005 07/01/2024. PLUM is an identifier of the union whose collectively bargained rate prevailed in the survey for this classification, which in this example would be Plumbers. 0198 indicates the local union number or district council number where applicable, i.e., Plumbers Local 0198. The next number, 005 in the example, is an internal number used in processing the wage determination. The date, 07/01/2024 in the example, is the effective date of the most current negotiated rate.

Union prevailing wage rates are updated to reflect all changes over time that are reported to WHD in the rates in the collective bargaining agreement (CBA) governing the classification.

Union Average Rate Identifiers

The UAVG identifier indicates that no single rate prevailed for those classifications, but that 100% of the data reported for the classifications reflected union rates. EXAMPLE: UAVG-OH-0010 01/01/2024. UAVG indicates that the rate is a weighted union average rate. OH indicates the State of Ohio. The next number, 0010 in the example, is an internal number used in producing the wage determination. The date, 01/01/2024 in the example, indicates the date the wage determination was updated to reflect the most current union average rate.

A UAVG rate will be updated once a year, usually in January, to reflect a weighted average of the current rates in the collective bargaining agreements on which the rate is based.

Survey Rate Identifiers

The ""SU"" identifier indicates that either a single non-union rate prevailed (as defined in 29 CFR 1.2) for this classification in the survey or that the rate was derived by computing a weighted average rate based on all the rates reported in the survey for that classification. As a weighted average rate includes all rates reported in the survey, it may include both union and non-union rates. Example: SUFL2022-007 6/27/2024. SU indicates the rate is a single non-union prevailing rate or a weighted average of survey data for that classification. FL indicates the State of Florida. 2022 is the year of the survey on which these classifications and rates are based. The next number, 007 in the example, is an internal number used in producing the wage determination. The date, 6/27/2024 in the example, indicates the survey completion date for the classifications and rates under that identifier.

?SU? wage rates typically remain in effect until a new survey is conducted. However, the Wage and Hour Division (WHD) has the discretion to update such rates under 29 CFR 1.6(c)(1).

State Adopted Rate Identifiers

The ""SA"" identifier indicates that the classifications and prevailing wage rates set by a state (or local) government were adopted under 29 C.F.R 1.3(g)-(h). Example: SAME2023-007 01/03/2024. SA reflects that the rates are state adopted. ME refers to the State of Maine. 2023 is the year during which the state completed the survey on which the listed classifications and rates are based. The next number, 007 in the example, is an internal number used in producing the wage determination. The date, 01/03/2024 in the example, reflects the date on which the classifications and rates under the ?SA? identifier took effect under state law in the state from which the rates were adopted.

WAGE DETERMINATION APPEALS PROCESS

1) Has there been an initial decision in the matter? This can be:

- a) a survey underlying a wage determination
- b) an existing published wage determination
- c) an initial WHD letter setting forth a position on a wage determination matter
- d) an initial conformance (additional classification and rate) determination

2) If an initial decision has been issued, then any interested party (those affected by the action) that disagrees with the decision can request review and reconsideration from the Wage and Hour Administrator (See 29 CFR Part 1.8 and 29 CFR Part 7).
