The County of Pettis is requesting the services of a consulting engineering firm to perform the described professional services for the Construction Engineering Services for a bridge replacement project. If your firm would like to be considered for the Construction Engineering Services, you may express your interest by responding to the appropriate office, which is indicated on the attachments. Limit your letter of interest to no more than five (5) pages. This letter should include any information which might help us in the selection process, such as your past experiences with MoDOT projects, your past experiences working with the County of Pettis, your ability to meet the timelines, the persons or team you would assign to the project, the backgrounds of those individuals, and other projects your company has recently completed or are now actively engaged in completing. **A digital copy of the letter shall be included in the envelope.**

DBE firms must be listed in the MRCC DBE Directory located on MoDOT's website at [www.modot.gov](http://www.modot.gov), in order to be counted as participation towards an established DBE Goal. We encourage DBE firms to submit letters of interest as prime consultants for any project they feel can be managed by their firm.

The County of Pettis will evaluate firms based on a) experience and competence b) the capacity of the firm to perform the work in the timeframe needed c) past performance and d) proximity to and familiarity with the project area (23 CFR 172 - Administration of Engineering & Design Related Service Contracts and RSMo 8.285 through 8.291).

It is required that your firm's Statement of Qualification (RSMo 8.285 through 8.291) and an Affidavit of Compliance with federal work authorization program along with a copy of your firm's E-Verify Memorandum of Understanding (15 CSR 60-15.020) be submitted with your firm's Letter of Interest, or be on file with the County of Pettis. The statement of qualification is not included in the total page count limit.
